



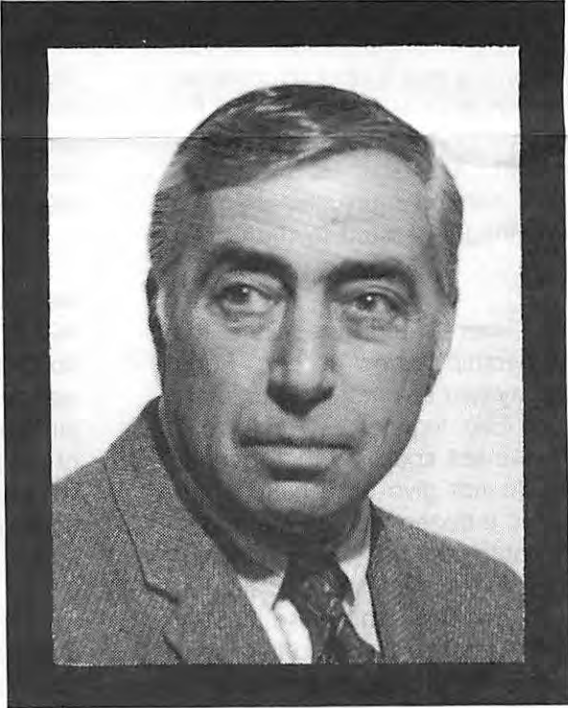

**John P. Spiegel, M.D.
Winner of the Third Annual
Distinguished Service Award**

Dr. John P. Spiegel, M.D., former President of the American Psychiatric Association, will be the recipient of AGLP's Third Annual Award for Distinguished Service to the gay and lesbian community at the Annual Awards Luncheon in Montreal on May 11th, 1988. Dr. Spiegel will be the keynote speaker at the luncheon and will be introduced by his long-time friend Bert Schaffner, M.D.

Dr. Spiegel was president-elect of the APA in 1974 during the period when a group of psychoanalysts led by Charles Socarides, M.D. forced a referendum on the Board of Trustees action which removed the diagnosis of homosexuality from *DSM-II*. Dr. Spiegel opposed the referendum contending that the elimination of the diagnosis of homosexuality as pathology had been based on scientific grounds. He felt that a political vote on a scientific question would taint the evaluation by the Board of Trustees and make the issue a "popularity contest." The Board of Trustees had hoped to keep the question confined to a clinical and academic one. Socarides, Bieber and other psychoanalysts who believed homosexuality to be a perversion, were allowed to present their view to the Board. When the Board ruled against them, they gathered enough signatures at an Annual Meeting of the American Psychoanalytic Association to force an American Psychiatric Association-wide referendum using a previously un-

Editor's Column

Montreal is only a few weeks away! I hope that you have your airline tickets by now and have registered for the La Citadelle, the Delta Montreal, or the Holiday Inn Centreville. As in past years, enclosed with this *Newsletter* you should find a pocket guide giving you tourist information and schedules. Steve Atkinson, M.D. is to be thanked for this year's *Guide*. Steve has been very busy trying to juggle schedules and accommodations from his office and home in Toronto. Given our extended supply lines, expect a change or two from the schedules listed in the *Guide* and this *Newsletter*.

We have added a few more members since the February *Newsletter*. Membership is now at 280. Forty members are residents, twenty-two are medical students, and thirty-two are self described females. (We have a number of members who have not specified their gender and who have names that do not give us a hint.) Two years ago, we had only about a dozen women members. The growth in the women's contingent has been gratifying. Peggy Hanley-Hackenbruck, M.D. deserves a special hand of praise for persevering in an organization so heavily monopolized by males. The women will want to take special note of the Lesbian Dinner which begins at the Hotel Meridien, Anjau B room at 6:00 pm on Tuesday.

We have gotten about a dozen new people requesting membership after seeing our advertisement about the Annual Meeting in *Psychiatric News*. Expect to see a number of new faces in Montreal. We need to make sure that we extend a warm hand of welcome. Most of us remember the terror we felt when we first got the courage

to attend an AGLP meeting. Let's make sure that the terror is short lived for this year's initiates.

Besides full members, AGLP has twenty-three *Newsletter* subscribers and twenty seven exempt *Newsletter* recipients (APA officers and officers of allied organizations). I want to express a special word of thanks to those members who have gotten in their dues. At the end of March, roughly 60% of our members had paid their dues. That ratio is a better than that which we had at this time last year. My greatest fantasy is to find that everyone has paid by the time of the Montreal meeting. Such an occurrence would greatly simplify the problems of getting the *Newsletter* out during the rest of the year.

The **Medical Student Travel Fund** has done quite well indeed. Over \$850 has been collected. This will allow AGLP to sponsor the American Medical Student Association's liaisons, Linette Atkinson and Keith Courtney, as well as help to defray the costs of a number of medical students who would not otherwise be able to come. Some of the students will be looking for local housing. Members who have contact with exemplary Montrealers who have additional space for a medical student or two should let us know.

The *Journal of Gay and Lesbian Psychotherapy*, Issue One is at the Production Facility for Haworth Press in Vermont. I sent the proposed cover back to the Art Department complaining that it was too stuffy. President's Column

Norman B. Hartstein, M.D.

As my first year as president of this Association comes to an end, I realize the wisdom of a two year term. So many of the issues and concerns on the agenda for 1987 remain unresolved. I need your help during 1988 to realize the goals of AGLP.

I hope that each member of AGLP will chose at least one issue or project on which to work during the year ahead. Among those issues and concerns facing us are:

1. The revision of ICD-10
2. Changing the curricula in medical schools and residency training programs about lesbian and gay men
3. Improving our media watch and response programs
4. Providing expert testimony and advice to judicial and legislative bodies
5. Opposing discrimination in the military
6. Repealing anti-sodomy laws and influencing AIDS policy regarding selection of meeting sites
7. Increasing the membership of AGLP and CHIP
8. Improving our links with other organizations of lesbians and gay men
9. Participating on AIDS committees on district branches and hospitals, and monitoring statements of psychiatric colleagues on AIDS
10. Preparing for the annual meeting for 1989 to be held in San Francisco.

It may seem premature to think about the 1989 Annual Meeting before we even begin the 1988 Conference in Montreal. However, last year we found a deadline for submitting program proposals that fell before our Fall Meeting. Let's take advantage of those opportunities when we are in Montreal to plan courses, symposia, and workshops for next year.

I would like to take this opportunity to thank all of you who have written to me during the last year and participated in AGLP activities. I want to acknowledge Steve Atkinson, M.D. for planning the montreal event and to David Scasta, M.D. for the *Newsletter* and the publicity of AGLP events. I look forward to seeing many of you in Montreal and hope that our next *Newsletter* will capture the event for those who are unable to attend the meetings this year.

Correction and Addenda

There was a typographical error in my last column. *Psychiatric News* did acknowledge that October was AIDS Awareness and Prevention Month. [The Editor apologizes for his error.]

My letter to *Psychiatric News* was printed in the January 15th issue in which the APA AIDS policy regarding confidentiality and disclosure as well as the guidelines for inpatient psychiatric units also appeared. I have been pleased with the articles on AIDS and HIV infection that have appeared in the last few issues of *Psychiatric News*. I regret that in responding to my letter, the editor of *Psychiatric*

News chose only to address the issue of quantity of coverage rather than the quantity of the coverage.

I recognize that reporting on AIDS poses some unique challenges. Since the Human Immunodeficiency Virus infected different communities in North America over a period of years, clinicians are confronting different stages of the epidemic. Reports that seem relevant to practitioners in certain urban centers seem irrelevant to clinicians elsewhere. Conversely, clinical experiences reported as "new" to some practitioners just encountering HIV-infections are likely to seem outdated to clinicians who have had more experience working with populations of gay men, IV drug users, or AIDS patients over the past few years.

We appear to be entering a new and controversial phase of reporting on AIDS. The contrast between the remarks attributed to a psychiatrist, Robert Gould, M.D., that appeared in *Cosmopolitan* and those espoused by Drs. Masters, Johnson, and Kolodny in their book on AIDS as reported in most national periodicals seem to be contradictory and confusing. I anticipate that "experts" will be lining up on both sides to debate issues regarding AIDS. I recently received a brochure describing a "conference you can't afford to miss" entitled, *The "New" AIDS Crisis Breaking Out*. This conference which is planned for Los Angeles, Chicago, New York, and Miami during the month of May will feature Drs. William Masters, Robert Kolodny, Helen Singer Kaplan, and Lorraine Day, among others. I still will be in Montreal when this conference is presented in Los Angeles but I would hope that someone from our membership on the AIDS Task Force would be able to attend to monitor these presentations and be prepared to respond if appropriate.

used bylaw that allowed grass-roots review of the political activities of the APA leadership. When the referendum could not be stopped, Dr. Spiegel, along with Al Freedman, President of the APA, Warren Williams, Speaker of the Assembly, and others, publicly called for the rejection of the Socarides initiative. The referendum to reverse the de-pathologization of homosexuality was defeated with 58% of the vote favoring the Board's decision. (The reader is referred to Ronald Beyer's book, *Homosexuality & American Psychiatry: the Politics of Diagnosis*, 1987 for a more detailed description of the conflict.) The margin of victory was narrow. Dr. Spiegel's public stand undoubtedly made a difference.

In the interim, Dr. Spiegel has continued to advocate non-pathological views of homosexuality. While president of the APA he publicly opposed efforts to fire teachers who were known to be gay or lesbian. Over the years, he has served as a ready source of political advice to those working on gay and lesbian issues within institutions and organizations.

Dr. Spiegel is a widower, the father of four children, and a social psychiatrist with a long list of publications. He cut his academic teeth on the treatment of war neuroses after World War II while serving as Chief of Professional Services in two army/air force convalescent hospitals. From the early 50's to the mid 60's he was involved in Family research and worked with Florence Kluckhohn, the Harvard Anthropologist. In 1966, he moved from Harvard to Brandeis University to become the Director of the Lemberg Center for the Study of Violence. From 1977 to 1980 he headed research in ethnicity and mental health at Brandeis. He currently is a full professor at Brandeis University.

In the APA, Dr. Spiegel has had a long and distinguished career. He is a Life Fellow in the APA and, besides serving as president, has served on many committees and task forces including the Task Force on Aggression and Violence, the Council of National Affairs, the Joint Conference Committee, the Task Force on Ethnic and Cultural Issues in Psychiatry, and the Task Force on Third Party Intervention in Community Conflict. He was president of the American Academy of Psychoanalysis and was the founder of the American Family Therapy Association. He is a member of the American Psychosomatic Society, The American Public Health Association, the Group for Advancement of Psychiatry, the American Sociological Society, and the American Association for the Advancement of Science. He is an honorary fellow in the Australian and New Zealand College of Psychiatrists and a member of the Royal College of Health in

England's Clause 28

England's Stop Clause 28 International Group reports that Clause 28 of the Local Government Bill "has been accepted by the House of Commons, approved with slight amendments by the House of Lords, and will go back to the Commons for its final reading next month. It is expected to become law in June of this year." The clause states:

A local authority shall not:

1. intentionally promote homosexuality or publish material with the intention of promoting homosexuality;
2. promote the teaching in any maintained school of the acceptability of homosexuality as a pretended family relationship.

Nothing in [the] subsection above shall be taken to prohibit the doing of anything for the purpose of treating or preventing the spread of disease.

England has always been somewhat prudish about matters of sexuality but its attitudes about homosexuality unfortunately remain a European aberration. Unlike her enlightened continental neighbors, England remains rooted in the nineteenth century of Oscar Wilde. The International Group is petitioning international support by asking concerned individuals to write letters of protest to the nearest British consulate. Under some interpretations of the law, even this *Newsletter* could be banned from libraries and "maintained" schools.
