#### **Editor's Column**

t is with very mixed emotions that I write this, my last editor's column. I indicated last year that I would resign from this position if a good candidate agreed to be nominated in 2001; I believe that Dan Hicks, head of the nominating committee, has found such a candidate.

I began my tenure in 1994, in Philadelphia, which is fitting, since that is where I completed my medical education and residency training. At the time, although I had been attending AGLP meetings avidly since 1988 when I was a PGY-2, I could never quite figure out how to get more involved. A spur-of-the-moment decision to accept the nomination as newsletter editor proved to be just the thing. All of a sudden I was thrust right into a pivotal point in the organization. It was quite a learning experience!

I remember meeting with David Scasta at his home in order to find out how to put the *Newsletter* together. It was somewhat intimidating; I was completely computer illiterate at the time. David had already come a long way from the "cut and paste" method you see in the early issues of the *Newsletter* which I have in my archives, and was already using the excellent Roy Harker to do layout and to supervise the printing and mailing.

Sometimes people are not clear on exactly what the newsletter editor does. The answer is EVERYTHING (aside from Roy's important contributions). For example, all of the photos (unless otherwise credited) are taken by the editor. Aside from editing articles, I often contacted people to suggest that they write articles on particular topics. Throughout the years, I got to interview many of our annual awardees, in some cases at their homes.

Most of the book reviews we have featured through the years are the result of my actively searching out interesting titles, obtaining them from the publishers and mailing them out to our members for their perusal.

I was also personally in touch with all of the APA candidates that we profiled over the years, and also wrote the questions and decided which races to feature from year to year (Margie Sved was a big help here). Believe me, I could have influenced a few elections if I had revealed how illiterate some of those candidates were! By the way, I want to let AGLP members know how important our "election issue" is, even to non-AGLP members; several times I was contacted by APA officials to make sure that we were running this feature, saying that the candidates looked forward to participating in it from year to year.

I have a number of thank you's to say: I learned a lot from all four of the presidents who served during my term: Margie Sved, David Scasta, Dan Hicks and Phil Bialer. Roy Harker has been a great pleasure to work with; the first time I met him I showed up at his apartment right after seeing my optometrist to have my eyes dilated. He was not only kind enough to lend me a pair of sunglasses so that I could walk down the street after our appointment, he has also been helping me out ever since. He is one of AGLP's greatest treasures.

In closing, let me just provide a little update on my life and explain why I have decided to resign. Last year, my partner Lewis and I decided to make a major life-change and sell our coop apartment in Manhattan. In June, we purchased a large home in a tiny village near New Hope, Pennsylvania. I am currently making the transition from urban sophisticate to landed gentry with mixed success. Instead of looking outside at traffic lights and street people, we look outside at our own little creek and at flocks of wild turkey and herds of deer. I want to devote more of my time to making this transition, and setting up a new life for myself. I do plan to continue to give of my time to AGLP in some capacity. #### Vice-President's Column: Saturday symposium asks, "Who are 'we'?"


he issue of transgender inclusion has been a focus of the AGLP business meetings for the past two years. Last year, the membership voted to have the president appoint a committee to propose bylaws amendments inclusive of trans issues and psychiatrists. The AGLP membership will vote on these bylaws changes at the New Orleans business meetings. In making these changes, AGLP will be following a path adopted by many other LGB organizations in the past decade.

Of course, trans issues are not new to AGLP psychiatrists. Issues of gender expression and identity occur in our gay and lesbian patients. As out LGB psychiatrists, many of us receive referrals of transgendered patients, as our colleagues may assume we have expertise in their care. We're aware that gay and lesbian youth exhibiting variant gender behavior have been diagnosed with Gender Identity Disorder of childhood, and that this diagnosis has been used by "reparative" therapists. LGB and transgendered folks face similar issues, such as coming out, and similar foes, such as societal intolerance and the social conservative movement.

Yet barriers remain in adding the "T" to "LGB." Many LGB psychiatrists are less familiar with literature pertaining to the care of trans patients than literature about lesbian and gay patient care. There is uncertainty and disagreement regarding the degree to which trans issues are linked to LGB issues. Difference can lead to tension, as it has at times between lesbians and gay men. Difference exhibited by trans people is highly stigmatized socially; it's not surprising that there has been tension at times between LGB communities and trans communities.

On Saturday, May 5, from 10a.m. to 1p.m. at the Chateau LeMoyne, AGLP will examine these connections and tensions. The AGLP Symposium, "Who are 'we'? Where sexual orientation and gender identity meet," features keynote speaker, Holly Devor, PhD. The symposium's goals are to improve our understanding of gender expression in our LGBT patients, our ability to care for transgendered patients, and our sense of how LGB psychiatrists and trans psychiatrists can work together within AGLP and the APA.

From Dr. Devor's website: "Dr. Holly Devor is professor of sociology at the University of Victoria, Canada. Dr. Devor specializes in the study of gender, sex, and sexuality in lesbian women, transgendered females, and female-to-male transsexuals. Her first book, *Gender Blending: Confronting the Limits of Duality*, in which she coined the phrase Gender Blending, examined the social construction of gender in society and its implications for the lives of females whose gender presentations mixed masculinity, femininity, and other characteristics to the point that their gender was not always recognizable to observers. Her second book, *FTM: Female-to-Male Transsexuals in Society*, provides a detailed, compassionate, intimate, and incisive portrait of the life experiences of 45 female-to-male transsexuals and suggests new theoretical frameworks for understanding the interplay of gender, sex, and sexuality. Her current research focuses on Reed Erickson, a transsexed man and founder of the Erickson Educational Foundation, who was instrumental in bringing issues of transgender and gay rights into public awareness. Dr. Devor is a renowned public lecturer and has made numerous appearances on television, radio and in print media."

Discussing Dr. Devor's presentation will be AGLP members Robin Dea, M.D., and David Seil, M.D. Drs. Dea and Seil are among the AGLP members most experienced in transgender care. At the conclusion of the symposium, informal discussion on this topic and on the week ahead can continue, as those interested take a group outing to Jazz Fest.

#### **AGLP Awardees to Be Honored in New Orleans**

t has been my privilege as past president to help select the persons who will be honored at our annual banquet on Wednesday, May 9th. I am pleased to announce that we are honoring two persons who have been on the forefront of breaking open doors for lesbian and gay people in the APA as well as fighting for the mental health of our community, and both practice in Boston, that hotbed of gay liberation.

Our Distinguished Service Award goes to Dr. Lawrence Hartmann, who served as President of the APA in 1991-92. In addition, Dr. Hartmann, along with Richard Pillard and others, was instrumental in helping to remove homosexuality from the DSM in 1972. Dr. Hartmann worked within the APA as chair of committees, Speaker of the Assembly, Trustee from Massachusetts, and Vice-President. By his presence and his influence, he helped change the thinking of many of our colleagues about homosexuality, and used his influence to help put lesbian and gay people on committees and in the Assembly, so that we had a voice to speak up on our issues. He also fought for representation and fair treatment for women, African-Americans, and other minorities, even before we had the Caucus. He also was instrumental in showing the American Psychoanalytic Association and others in the analytical community how their stance was detrimental to the mental health of our community, and so helped to change their stance on homosexuality.

Dr. Marshall Forstein will be receiving the James Paulsen Award for Distinguished Service to AGLP, but his influence goes far beyond our organization. Marshall served as president of AGLP several years ago, but continues to stay active in our organization, including helping to lead the symposium this year on the effects of reparative therapy. For many years, Marshall taught courses on treating gay and lesbian patients, as well as those with HIV. He has influenced many of us to become leaders and teachers in this area through his example. In Boston, as the Medical Director of the Fenway Center, he is acknowledged as an authority in these areas, and has not only provided good mental health care, but he has taught medical students, residents, social workers, psychologists, colleagues and everyone he has come into contact with how to treat their patients with basic human dignity and non-discrimination. As Chair of the AIDS Commission of the APA, he has been a tireless leader in speaking out about AIDS: prevention in vulnerable populations, treatment in substance abusers and chronically mentally ill, and treating the neuropsychiatric aspects of AIDS, culminating in publication of treatment guidelines last year. And now, through his personal life and his teaching, he has become the spokesmodel for gay and lesbian families, writing and lecturing on special issues related to gay and lesbian parents and children.

Please be sure to get your banquet tickets as soon as possible, and help me acknowledge these two friends and colleagues who are also internationally acknowledged leaders in mental health and psychiatry.



#### **Transgender Task Force Submits Proposal**

ast September, Phil Bialer charged me with heading a task force to come up with a proposed change to the AGLP bylaws that would include more welcoming language for transgendered members. This followed the defeat of the previous bylaws proposal that was thought to be too broad and perhaps ambiguously worded.

Through invitation and volunteering, the task force was formed, and included Jack Drescher, Dan Karasic, Wynelle Snow, and myself. We are all members in favor of trans inclusion, which had not been my original intent for the task force. However, my efforts to recruit members with a broad range of opinions on the subject, through invitation and solicitation of volunteers, were unsuccessful. We reached a proposal which would represent a substantial change for the organization, but is also specific and unambiguous.

One criticism of the previous proposal had been that the bylaws were changed in too many places, perhaps representing too big a shift for some members. We considered adding a statement of transgender inclusion to the first part (Object section) of the bylaws, while leaving the rest as is. However, the consensus of the task force was that such a change would give a mixed message to potential transgendered members (and to those of us not identifying as transgendered as well). Since a large number of the references to "LGB" in the body of the bylaws deal with educational issues, it would also seem logical to change these to reflect the educational activities we already undertake at our annual meeting.

Below are the proposed changes, underlined throughout the bylaws. We expect that this proposal may generate some controversy, and we welcome any member's comments in support or dissent. The proposal will be discussed and voted on at the Annual Meeting this May in New Orleans, during the AGLP business meetings on Monday and Tuesday evenings. Any AGLP member may attend the meetings to participate in the discussion, and any member may submit written amendment proposals or comments to be read at the meeting in the event she or he can't attend.

Change in any organization can be uncomfortable, even painful. However, I think that AGLP is a strong enough organization to handle some growing pains as we wrestle with this issue. I would much prefer a lively debate about this proposal in May than silent acceptance with bitter feelings, or the slipping away of valuable members. I also remain mindful of the effect that more explicit transgender inclusivity in AGLP might have on lesbian-only events, and the potential need to advertise such events specifically as such in future programs.

#### AGLP BYLAWS CHANGE PROPOSAL

We propose changing "gay, lesbian, and bisexual," to "gay, lesbian, bisexual and transgender" everywhere this phrase occurs in the bylaws. Additionally we propose changing "homosexuality" in the places where it occurs in the Object section (Article II, Section 1). Note that the name of the organization would remain the same.

The specific changes are underlined below:

Proposed Changes to the Bylaws of the Association of Gay and Lesbian Psychiatrists

Article I. Name.

The name of this organization shall be the Association of Gay and Lesbian Psychiatrists.

#### Article II. Object.

Section 1. The goals and objects of the Association are:

To provide a professional, social and educational group for psychiatrists who are gay, lesbian, bisexual, or transgendered and/or engaged in the treatment of gay, lesbian, bisexual, and/or transgendered patients,

To promote greater understanding in the members of this Association, our colleagues, and the public in matters related to <u>sexual orientation</u> and gender identity,

To promote fair and equitable treatment of all people without regard to sexual orientation or gender identity,

To diminish stigma, intimidation, and physical violence directed towards gay, lesbian, bisexual, or transgendered persons,

To promote the development of improved mental health services for gay, lesbian, bisexual, and transgendered persons,

To promote and encourage research in areas related to sexual orientation and gender identity,

To promote the scientific education and training of psychiatrists and other mental health professionals involved in the treatment of gay, lesbian, bisexual, <u>and transgendered</u> people.

Section 2. This organization is organized exclusively for educational purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code. Notwithstanding any other provisions of these articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law) or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).

#### Article III. Officers.

Section 1. The officers of the Association shall consist of the President, Vice President, President Elect, Immediate Past President, Secretary, Treasurer, and Newsletter Editor. The Executive Committee shall consist of all officers of the Association as described above. The Office Director shall be an ex-officio member of the Executive Committee.

Section 2. Duties. The officers shall perform duties prescribed by these bylaws and the parliamentary authority adopted by the Association. The Executive Committee may determine duties of officers beyond those designated in these bylaws. Duties of the officers include:

- A. President: Functions as the executive officer of the Association in principle, planning, and operation; presides at general meetings of the Association and of the Executive Committee; speaks for and represents the Association, and keeps the Executive Committee informed of developments and proceedings.
- B. Vice President: participates with the President in all matters of policy determination and decisions; presides over general membership and Executive Committee meetings in President's absence; collates and sets the scheduling of all the Association activities during the Annual Meeting as may be required by the President, Executive Committee, Board of Directors or individual members of the Association.
- C. President Elect: participates with the President in all matters of policy determination and decisions; familiarizes her or himself with the history, purposes, goals, and ongoing activities of the Association.
- D. Past President: participates with the President in all matters of policy determination and decisions; serves as historian and consultant to newly elected officers in affairs of the Association and aids officers in achieving continuity in the affairs of the Association and archiving of important historical documents; with the approval of the Executive Committee, annually selects person(s) to be recognized for distinguished service to the gay, lesbian, bisexual, and <a href="mailto:transgender">transgender</a> communities both within and without the Association.
- E. Secretary: Collects reports of all activities of various elements of the Association and keeps the Executive Committee informed of these activities; takes minutes at general membership business meetings, Board of Directors and Executive Committee meetings and makes these minutes available to members through the *Newsletter* of AGLP.
- F. Treasurer: Collects, disburses, and keeps accounts of funds of the Association; maintains, with the help of the Office Director, records of dues owed and paid and ensures that members are regularly informed of membership expiration and dues to be paid; keeps the Executive Committee informed of the financial state of the Association and makes a financial report to the membership at the time of the Annual Meeting; constructs a budget annually as approved by the Executive Committee; along with the President authorizes all disbursements of budgeted moneys; along with the President, authorizes all disbursements of non-budgeted moneys in cases of small disbursements or in cases of emergency such that there is insufficient time for authorization by the Executive Committee; and audits the expenditures of the national office.
- G. Newsletter Editor: Edits and distributes a newsletter at least 4 times per year; edits and distributes other mailings as directed by the Executive Committee; publishes the minutes of the Association.

#### Section 3. Election of Officers.

- A. All officers, since they must be readily available to members, to media and to American Psychiatric Association officers and committees, must be prepared to openly and publicly identify themselves as gay, lesbian, bisexual, or <a href="mailto:transgendered">transgendered</a>.
- B. Time: Elections shall be held either by mail before the Annual Meeting or at the membership meetings of the Association during the Annual Meeting.

C. Nominations: The President shall appoint from three to five members of the Board of Directors in good standing to nominate officers for the Association. Nominations shall be presented to the Association at the first membership meeting of the Annual Meeting, or by mail if not otherwise feasible. The president shall at that time accept additional nominations from the floor (or by mail if the election is by mail). All nominations from the floor or by mail must be seconded by a member of the Association in good standing. In no case may a member be nominated for office who is not in good standing with the Association.

D. Balloting: Balloting shall be at the second membership meeting of the Association during the Annual Meeting (or, if by mail, around the time that the Annual Meeting usually is held). Signed ballots of members unable to be present at such a meeting may be submitted to the Secretary at a prior time. Counting of ballots shall be by the Secretary, Treasurer, Vice President, and President Elect who shall serve as a Board of Tellers. This count shall be accomplished immediately after balloting and results announced at the meeting at which balloting occurs. In the case of uncontested offices, an oral vote may be taken if there are no objections.

#### Section 4. Eligibility, terms, vacancies and succession to office.

A. Any member of the Association defined as a full and voting member, who is not a member of the Board of Directors, and who is prepared to openly and publicly identify themselves as gay, lesbian, bisexual, or <u>transgendered</u>, is eligible to become an officer of the Association as defined in Section 2A above. A Board of Directors member may become an officer by resigning his or her post upon election to office.

B. The term of office for the President shall be for two years. The term of office for all other officers, including the Past President, shall be for one year (or, from the date of election to the date of the next subsequent election of officers).

C. The President shall not hold office for more than two consecutive terms. Other officers shall not hold the same office for more than four consecutive terms.

D. A vacancy of the office of President shall be filled by the President Elect becoming President. A vacancy in the office of President Elect shall be filled by nomination by the Executive Committee and a mail ballot of the voting membership. Other office vacancies shall be filled by majority vote of the Executive Committee.

E. Recall. Recall of an officer may be accomplished by: a petition to the President signed by 20% of the voting members followed by vote, which may be by mail, of a simple majority of the voting members. In case of emergency, as defined by the President, any officer may be removed immediately by two thirds vote of the Executive Committee. If the potential object of actions is the President, the Vice President may declare an emergency and call for action by the Executive Committee.

#### Article IV. Membership

Section 1. Any member in good standing with the American Psychiatric Association who supports the objectives of the Association may be a general member at the discretion of the Executive Committee by notifying the Executive Committee or the Office Director of his or her desire to join and by paying dues. Membership continues so long as American Psychiatric Association membership is maintained and dues to the Association are paid. Members may resign upon request to the Secretary of the Association. Membership may be terminated by 3/4 vote of the Executive Committee for conduct considered to be in opposition to the objects of the Association.

Section 2. Affiliation. Any person who does not qualify for general membership but who supports the object of the Association may become an associate member by notifying the Executive Committee or Office Director of her or his desire for affiliation and paying dues. Such associate member may not vote or hold office in the Association.

Section 3. Dues. The Executive Committee will determine the amount of dues and their time and method of payment. Changes in dues charged to members by the Executive Committee must be approved by the Board of Directors or, in emergency, by mail ballot of the Board of Directors.

Section 4. Responsibilities. Members may not speak for or otherwise represent the Association without knowledge and consent of the President.

Section 5. Membership List. The membership list of the Association shall be confidential and available only to members of the Executive Committee and Membership Committees for use in activities of the Association. Relevant portions of the membership list may be released to Board of Directors Members listing their respective constituencies. Failure to maintain confidentiality of the membership list shall be grounds for removal from membership and/or office under the procedure outlined in Section 2 above. In the event that the President has been charged with an unauthorized release of the membership list, the Vice President will adjudicate consideration for removal.

#### Article V. Meetings.

Section 1. Two business meetings of the Association shall be held during the Annual Meeting at such time and place as designated by the President. Business meetings shall be open to anyone desiring to attend who supports the goals of the Association and does not interfere with, or is disruptive of, the meetings. Members who wish to introduce items of business at the meetings are encouraged to inform the President in advance of the Annual Meeting. The President will chair the business meetings. All actions taken during the business meetings shall be noted in minutes taken by the Secretary of the Association. Each officer of the Association shall report on his or her respective activities on behalf of the organization. The Treasurer will report on the financial affairs of the Association at this time. The Treasurer shall respond, within reason, to any questions about the finances of the Association from any member of the Association. Additional reports from Board of Directors members and others designated by the President will also be heard at this time.

Section 2. Annual Meeting. The Annual Meeting of the Association is the general meeting at which officers are elected and the business meetings are held, usually in conjunction with educational, professional and social activities for the general membership.

Section 3. Board of Directors Meeting. Each year, generally in the fall, the President of the Association shall call a meeting of the Executive Committee and the Board of Directors to plan for the Annual Meeting and plot future directions for the Association. The President shall select three to five members of the Board of Directors to serve as a nominating committee for the officers of the association. The nominating committee shall be prepared to present a slate or slates of officers at the first membership meeting of the Annual Meeting (or, by mail if not otherwise feasible).

The Executive Committee shall meet separately from the Board of Directors meeting to address the designated concerns of the Executive Committee and other issues as the Executive Committee may feel appropriate. The Executive Committee will then join the Board of Directors for a joint planning meeting. The joint planning meeting will be chaired by the President of the Association. Minutes of the Board of Directors meeting will be taken by the Secretary of the Association. The Executive Committee may present to the Board of Directors at this time (or, alternatively, at the Annual Meeting) a request to approve changes in the dues charged to members of the Association. After discussion the President shall poll the members of the Board of Directors for approval or rejection of the Executive Committee's request to change the dues. A simple majority vote of the Board of Directors shall be sufficient to authorize the change. Except in an emergency (which may be declared by majority vote of both the Executive Committee and of the Board of Directors), changes by the Executive Committee in dues which have been approved by the Board of Directors will be announced at the next Annual Meeting with the change to become effective on the first day of the January following that Annual Meeting. Additional Association business may be acted on at this time with each member of the Board of Directors and each officer having one vote, except for the president who votes only in case of a tie vote. The Board of Directors is an advisory body to the Executive Committee. Ultimate administrative responsibility for the Association lies with the Executive Committee. In cases of serious division between the Executive Committee and members of the Board of Directors (with the exception of matters relating to dues), the President may call the Executive Committee into executive session and if, after discussion, the division remains, the wishes of the majority of the Executive Committee shall prevail.

Section 4. Additional Executive Committee and/or Board of Directors meetings shall be held at times and places determined by the President. These may be by telephone conference call or other forms of electronic or written media.

Section 5. Special meetings may be called by the President for the specific purposes of urgent nature which cannot wait for a general meetings.

#### Article VI. Executive Committee

Section 1. Members. The officers of the Association shall constitute the Executive Committee.

Section 2. Powers and duties. The Executive Committee shall have supervision and policy direction of the affairs of the Association between membership meetings and fix the time and place of those meetings. The Executive Committee interprets the bylaws, but shall be subject to the orders of the Association, and none of its acts shall conflict with action taken by the Association. The Executive Committee shall determine all disbursements of moneys made by the Treasurer and may authorize disbursements up to a specified amount without specific approval. Investment of Association funds in investments other than bank and insured money-market funds must be approved by the Executive Board.

Section 3. Meetings. The Executive Committee shall meet during the Annual Meeting of the Association, in conjunction with the Board of Directors Meeting, and additionally as determined necessary by the President; such meeting may be conducted by phone or other electronic media. Meetings may be initiated by any member of the Executive Committee with the approval of the President. In the event the President does not approve, a meeting may be called with the agreement of any three members of the Executive Committee.

#### Article VII. Board of Directors

The Board of Directors shall be composed of officers of the Association, representatives of constituency committees, chairs of standing task committees, and up to 5 Directors appointed by the President for specific purposes. The number of Directors may fluctuate from year to year. A substitute representative may fully participate in the Board of Directors meetings when the designated representative is unable to attend. In cases in which the official representative for a Board of Directors position is disputed, the President shall decide the dispute. In cases in which a Board of Directors position is unrepresented, the President shall endeavor to assign a representative. Although a Board member may be a member of more than one constituency group, directorship or task force, no member may represent more than one position on the Board of Directors. A quorum of the Board of Directors shall consist of the President or her or his designate, and at least 6 additional Board of Directors representatives. The Office Director shall be an exofficio member of the Board of Directors. General members of the Association may attend the Board of Directors Meeting and may, if time permits and the President approves, speak during Board of Directors Meetings.

Section 1. The constituency committees represented by a Director may include, but are not limited to, the following: women members, medical students, psychiatric residents and fellows, early career psychiatrists, ethnic minority members, psychoanalysts, child and adolescent psychiatrists, and HIV-affected members. Each constituency shall yearly select a representative to serve on the Board of Directors, by whatever manner it deems appropriate. Each constituency must chose a Director and notify the President of their choice prior to the adjournment of the Annual Meeting of the Association. Any contingency of the Association which meets in conjunction with any Association meeting must send a representative to the Board.

Section 2. The standing task committees represented by a Director shall be a Journal Editor, appointed annually by the Executive Committee; and a Local Arrangements Director, a Membership Director, and a Preconvention Director who shall be appointed annually by the President.

A. Journal Editor. Publishes and distributes to the membership and others, a professional and scientific journal at least semi-annually, containing studies, expertise and observations relating to the equitable and affirming treatment of psychological and psychiatric issues affecting gay, lesbian, bisexual, and transgendered people.

- B. The Local Arrangements Director shall coordinate the arrangements for the Annual Meeting. The Director shall live in close proximity to the Annual Meeting site. The Director shall appoint a committee to advise and aid the Director in this task. The committee must also carry out the following tasks: design, fabricate and execute publicity displays such as the Association Educational Exhibit at the Annual Meeting; and compile and publish a guide and other information about the Annual Meeting and the Annual Meeting site.
- C. The Membership Director shall develop policies, media coverage and programs to expand the membership of the Association. The Director shall appoint a committee to advise and aid her or him in membership development. The Office Director shall work closely with the Membership Director to promptly answer letters of inquiry about membership.
- D. The Preconvention Director shall design and coordinate an educational program for members of the Association addressing current and relevant topics on gay, lesbian, bisexual, <u>or transgender</u> matters to be presented prior to the Annual Meeting of the American Psychiatric Association.

Section 3. Up to 5 special task force chairs shall be selected each year by the President to address special issues and tasks chosen and assigned by the President. The President may appoint or disband special task forces at anytime during the year as he or she sees fit. More than 5 task forces may be appointed, but only 5 may be selected by the President to serve on the Board of Directors. Article

#### VIII. Office Director.

Section 1. The Office Director shall be a paid employee of the Association who staffs and clerically administers the national office of the Association. The Director shall report to the president and may be hired or fired by simple majority vote of the Executive Committee. The Executive Committee shall determine compensation of the Director. The Director shall be bondable and shall personally support the goals and objects of the Association.

#### Section 2. The duties of the Office Director shall be as follows:

- A. The office director shall maintain an office and provide regular continuous staffing of that office such that letters, telephone calls and other forms of inquiry from members or the public are responded to promptly and directed to the proper source for resolution or response. The office director shall purchase routine office supplies, services, equipment and furnishings to maintain the office within budgetary constraints set by the Executive Committee.
- B. The office director shall provide members with clerical help to accomplish tasks ordered by the Association officers, Board of Directors or membership body. The Director shall remind, in a timely fashion, members of tasks that need to be accomplished and insure follow through on all formally approved actions of the Association.
- C. The office director shall attend the meetings of the Board of Directors, the membership meetings, and where feasible, the Executive Committee meetings. The office director shall be an ex-officio member of the Board of Directors and the Executive Committee.
- D. The office director shall attend the Annual Meeting and shall provide logistical and clerical help to the officers and directors of the organization at that time. The Director will insure that contracts for the exhibits booth and furnishings, meeting rooms, entertainment, etc. are completed in a timely fashion and sent to the appropriate officer for approval.
- E. The office director shall receive submissions for the journal of the Association and shall refer them to the Journal Editor. The office director shall provide clerical support to the Journal Editor throughout the process of selection of articles for the journal and shall communicate with the authors of submitted articles on behalf of the editor. The office director shall insure that copyright agreements are signed for all journal articles prior to publication.

- F. The office director shall receive submissions for the newsletter of the Association and shall refer the submissions to the Newsletter Editor. The office director shall insure that the newsletter is properly laid out, printed and distributed to members in a timely fashion.
- G. The office director shall maintain the mailing, dues and membership lists and shall fastidiously guard the confidentiality and privacy of those lists. Under no circumstances is the list to be released to any party except as defined in these bylaws.
- H. The office director shall collate and publish a membership directory listing only those members of the Association who ask to be included in a non-confidential membership directory. The Membership Directory shall be distributed only to members of the Association in good standing.
- I. The office director shall collate and publish a referral guide listing the Association members who are full or associate members in good standing who have asked to be listed in a non-confidential referral guide for patient's seeking therapy from a therapist who is affirming of gay, lesbian, bisexual, and transgendered people. The Referral Guide may be distributed, within reason, to anyone requesting such a guide and shall automatically be sent to all members of the Association in good standing.
- J. The office director annually shall prepare a financial report of all office expenditures for the Treasurer.
- K. The office director shall perform additional tasks as may be directed by the President or Executive Committee providing such tasks do not conflict with these bylaws.

#### Article IX. Parliamentary authority.

Robert's Rules of Order, Newly Revised shall govern the Association in all cases to which they are applicable and in which they are not inconsistent with these bylaws and any special rules or order that the Association may adopt. The rules may be informally applied if there are no objections.

#### Article X. Amendment of the Bylaws.

Petition to amend these by-laws may be made in writing to the Secretary if signed by 10 general members, and suggestions for changes in these by bylaws may be proposed by the Executive Committee. These bylaws may be amended at the Annual Meeting of the Association by a two-thirds vote, provided the amendment has been submitted to the Secretary in writing at a previous general meeting. During the Annual Meeting, bylaws changes may be proposed at the first business meeting and approved at the second business meeting.

#### Article XI. Distribution of assets on dissolution.

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious and/or scientific purposes and which has established its tax-exempt status under section 501 (c) (3) of the Internal Revenue Code. The nonprofit organization shall be determined by the Executive Committee and shall have goals consistent with the object of the Association.

#### Letters to the Editor...



#### Dear Editor:

We are happy to inform the AGLP members that the Norwegian Psychiatric Association (NPA) finally passed a statement against reparative therapy during the Annual Meeting on October 13. 2000. Last August we wrote here in the *Newsletter* about the ongoing struggle. In 1999 we put forward a similar statement, but after a discussion uncovering much disagreement and anti-homosexual bias, it was decided to let the board work further on the statement. This year the discussion was much more focused and our colleagues more accepting. The statement was presented by the board and got 66 votes pro and 6 contra and 4 were blank. It uses the Norwegian term homophile (meaning gay and lesbian) instead of homosexual. This reflects the dominating essensialistic view of the psychiatrists in Norway regarding homosexuality

#### The statement says:

Homosexuality is no disorder or illness, and can therefore not be subject to treatment. A `treatment` with the only aim of changing sexual orientation from homosexual to heterosexual must be regarded as ethical malpractice, and has no place in the health system.

Homosexuals have, as everyone else, of course, a right to help and treatment that follow recommended guidelines, whether this is related to their sexuality or not.

This statement - short and to many people self evident today - is rather important and fills the gap left by the NPA-statement in 1977 that resulted in the removal of homosexuality as a diagnosis in Norway. It emphasizes ethical arguments and is important in preventing some Norwegian psychiatrists who mix up their religious interest or psychoanalytic orthodoxy with professional ethical standards.

We are very grateful to AGLP and the work of its members making it possible for APA to pass their statements. We especially thank the AGLP International Committee with Kenn Ashley and Gene Nakajima and the distinguished authors Jack Drescher and Richard Isay for their support and inspiration.

As you can tell, this business of confidentiality and anonymity gets incredibly complicated, but the fact remains that there is still a wish on the part of most positive AGLP members to remain anonymous within our organization. I look forward to a time when all of us can proudly stand up and be counted and speak up as openly positive psychiatrists, similar to the gradual process I have experienced in the AGLP of members gradually coming out as gay, lesbian, bisexual, and transgendered persons in the 23 years I have belonged to this organization and its predecessor caucus, and this coming out could start with the AGLP and progress to the APA if that is where people want to take it. know this: I do not wish to impose any agenda of mine on the rest of you, for each of us is in a different situation. I am retired, and find it much easier to be out as positive.

CHINESE HOMOSEXUALITY DEPATHOLOGIZED.

The most exciting news recently has been the Chinese Psychiatric Association's (CPA) decision to delete homosexuality as a mental illness. The 1994 edition of the CPA's official nosology of mental illness stated its opposition to the World Health Organization's ICD-10 position that homosexuality is no longer a mental illness. Chinese gay activists approached AGLP for help, and I wrote an article encouraging AGLP members to write members of the CPA. In addition, I asked Ellen Mercer of the American Psychiatric Association's International Affairs office to write a letter requesting the Chinese Psychiatric Association to stop classifying homosexuality a mental illness. When the APA president met our Chinese colleagues at an APA-CPA co-sponsored conference in Beijing a couple of years ago, he raised this issue in his conference talk. The Los Angeles Times article concerning this change stated, "Part of the task force's [assigned to overhaul China's classifications of mental illness] research included contact with the American Psychiatric Association, which urged the Chinese group to change its stance." It is significant that a mainstream newspaper mentioned the APA's specific role in fostering a change in the world's views about homosexuality. A few years ago, the APA was also instrumental in helping the Japanese Psychiatry and Neurology Association publically state their depathologization of homosexuality.

Rather, they focus on a set of interrelated issues of far greater salience in our time, the developmental and psychological consequences of identifying as homosexual and of having lesbian relations. Lesbian Lives is a heartening sign of the generous scholarship and humane impulse that are transforming psychoanalysis in our time.
