It seems that every week I am contacted about LGBTI refugees fleeing persecution in their home countries who need psychiatric/psychological evaluations as part of their applications for asylum here in the U.S. Fleeing with only what they are carrying, they do not have the evidence to prove the persecution they have suffered, except for the scars on their bodies and in their psyches. Your clinical findings, however, ARE evidence in a court of law.

Many times the answer to the request for a psych evaluation is no, as there are just not enough mental health professionals trained and willing to provide these life-saving evaluations. It is heart-breaking to say no, as 76% of asylum applicants will be deported to their home countries without an evaluation or legal help. Provide an evaluation, and chances for being granted asylum soar to more than 90%.

As trained heath professionals, you know all you need to know to provide these assessments. It is, I promise, the most rewarding volunteer work you can do. The work will deepen your clinical skills and sharpen your writing. Come to this training, a Symposium on Tuesday morning, May 6th, and leave with the knowledge, skills and support to take on your first case. There could not be a better time to learn to do this work, as we are beginning to see more and more people fleeing Russia, Uganda, Nigeria, India, Belize, Cameroon....It is global LGBTI health right here at home.

#### **AGLP 2014 Award Winners**

The Executive Board of the Association of Gay and Lesbian Psychiatrists proudly announces the 2013 Award Winners:

#### 2014 James Paulsen, M.D. Award

The 2014 James Paulsen Award is presented to an AGLP member who has made significant contributions to the ongoing life of the organization. It was named after a founding AGLP member. This year the award is being presented to long-time member **Philip A. Bialer, MD**, for outstanding contributions on behalf of the LGBT Community and service to AGLP, among other things, as Past President, Caucus Representative, and current Co-Editor of the Journal of Gay and Lesbian Mental Health.

Dr. Bialer received his undergraduate degree from the University of Rochester and went on to medical school at Ohio State University. After a one year internship in Internal Medicine at Mt

Sinai Medical Center, Dr. Bialer completed his Psychiatry residency at SUNY-Downstate. He then was accepted as the first Consultation-Liaison AIDS Fellow at the Beth Israel Medical Center in New York City (one of the first such positions in the country). Dr. Bialer stayed on at Beth Israel to develop the AIDS Psychiatry program. He was the Chief of the Division of Consultation-Liaison Psychiatry and Psychosomatic Medicine and the fellowship training director at Beth Israel from 1993-2008. While at Beth Israel, Dr. Bialer was also the director and PI of a Ryan White-funded program that provided mental health services to patients with HIV/AIDS attending MMTP and was one of five Physician-Ethicists leading the Ethics Program. Dr. Bialer is past president of Society for Liaison Psychiatry and currently sits on the Council of the Academy of Psychosomatic Medicine as chair of the Education Committee. Dr. Bialer is also a past president of the Association of Gay and Lesbian Psychiatrists and currently is a member of the APA Assembly as the Representative for the Caucus of Lesbian, Gay and Bisexual Psychiatrists. In 2014 he became co-editor in chief of the Journal of Gay and Lesbian Mental Health. He is a Fellow of the Academy of Psychosomatic Medicine and a Distinguished Fellow of the American Psychiatric Association.

In 2009, Dr. Bialer joined the faculty of Memorial Sloan-Kettering Cancer Center as a member of the Communication Skills and Research Laboratory and to serve as the Associate Program Director for the Psychosomatic Medicine Fellowship. He is an Attending Psychiatrist at MSKCC and an Associate Professor of Clinical Psychiatry at Weill-Cornell Medical College.

#### 2014 Barbara Gittings Award

The 2014 Barbara Gittings Award is presented to **Ida Hammer**, Peer Health Navigator, The Center for HIV Educational Studies & Training (CHEST)

Ida joined CHEST in November of 2012 as a Peer Health Navigator working with trans women to support their health goals and well-being. Prior to joining CHEST, Ida was a member of the Sylvia Rivera Law Project's Movement Building Team and had worked as the coordinator of the Transgender Legal Defense and Education Fund's Name Change Project. She has also been an organizer of the Philadelphia Trans-Health Conference. In 2011, she started the Trans Women's Anti-Violence Project as a trans feminist initiative to address violence and

oppression experienced by trans women. She regularly gives presentations and facilitates workshops at conferences and has conducted trainings with law firms, health care providers, and universities on issues affecting trans women. In 2013, Ida was named as one of the inaugural Trans 100 for her advocacy work. She is also a proud dyke-identified trans woman, and an organizer for the New York City Dyke March.

The Barbara Gittings Award is presented to a woman who demonstrates exceptional leadership and advocacy for lesbian Issues. It was named after one of the founders of the gay rights movement and one of the activists instrumental in moving APA to consider depathologizing homosexuality.

#### The 2014 Distinguished Service Award

The 2014 Distinguished Service Award for considerable and significant contributions to the wellbeing of the LGBT community, most notably through many years of mental health and advocacy programs at the Gender Identity Project at the LGBT Community Services Center and Office of LGBT Health at the Mount Sinai Health System is being presented to Barbara E. Warren, Psy.D., LMHC, Director for LGBT Health Services at Mount Sinai.

Dr. Warren is Director for LGBT Health Services at Mount Sinai Beth Israel/Mount Sinai Health System in New York City. For the past two years she served as Distinguished Lecturer and Director, Center for LGBT Social Science and Public Policy

at Hunter College, City University of New York. For over 21 years, Dr. Warren served on the senior management team of the Lesbian, Gay, Bisexual and Transgender Community Center of New York City, where she was the inaugural Director for the Center's behavioral health programs and as Director for Planning and Research was responsible for the Center's local and national health policy and government relations initiatives.

The Distinguished Service Award, AGLP's first designated award, is given to an individual for outstanding contributions to the LGBT community. Over the years it has been awarded to AGLP members whose work extends past the reach of the organization, to supportive APA officials, and to public figures.

### Journal of Gay and Lesbian Mental Health 2014 Outstanding Resident Paper Award

Scott Summers, MD, psychiatry resident at the University of California-Davis Medical Center, has been chosen recipient of the Journal of Gay and Lesbian Mental Health 2014 Outstanding Resident Paper Award. He was chosen for his case study, "New Onset Psychosis Following Abrupt Discontinuation of Hormone Replacement Therapy in a Transwoman"

Scott Summers was born and raised in Fresno, the heart of California's Central Valley. He attended local community colleges prior to matriculating to the

University of California-San Diego where his undergraduate studies were in biochemistry and cell biology. Following this, he attended the University of California-Irvine and completed their combined MD/PhD Medical Scientist Training Program. His doctoral thesis in pharmacology involved the development of new drugs to treat the effects of chronic exposure to low gravity.

During his core third year clerkships in medical school, he was strongly drawn to psychiatry both because of the dramatic effects medications could produce for patients, but also the chance to deeply understand people's lives in a way that

was unavailable to other specialties. After graduation from medical school, he began a general psychiatry residency at the University of California-Davis Medical Center. During this time he has conducted clinical research on Fragile-X syndrome and drug trials for autism related conditions. He has also been active in the hospital's GLEE (Gays, Lesbians and Everyone Else who cares) group that organizes a hospital wide Coming Out Day annually and has been instrumental in deploying one of the nation's first gender identity and sexual orientation Epic EMR templates. He is presently finishing up his fourth and final year of training with plans to begin an academic career with the local Veterans Affairs hospital.

The JGLMH Outstanding Resident Paper Award includes a \$500 cash award and assistance with travel to the AGLP Annual Meeting in New York where Dr. Summers will present his paper, and publication in the Journal of Gay and Lesbian Mental Health. The award was initially supported by a generous grant from the William A. Kerr Foundation, and is being sustained by AGLP member dues and contributions.

The Journal of Gay and Lesbian Mental Health (JGLMH) Outstanding Resident Paper Award for an outstanding paper written for publication by a psychiatry resident or other trainee. This award was supported in its first year by a generous grant by the William A Kerr Foundation, and includes a cash award, publication in JGLMH, and presentation of the paper at the AGLP meeting.

#### 2014 Stuart Nichols Award

The Stuart Nichols Award is presented to a community service organization in the Annual Meeting city that supports LGBT Mental Health. It was named after Stuart Nichols, MD, a community psychiatrist who did addictions and HIV work and was a mentor to many AGLP members, and includes a cash award. This year's award is presented **The Rainbow Heights Club**.

Rainbow Heights Club, located in Brooklyn, New York, is an advocacy program for lesbian, gay, bisexual and transgender consumers requiring mental health services. They provide socialization, support, peer advocacy, and a safe place for their LGBT clients to take the next step on their road to emotional recovery and wellness.

The award will be presented Monday, May 5, 2014, at a ceremony at the Norwood Club, 241 W 14th St, New York, NY 10011. The reception begins at 7:00pm and the awards ceremony itself will begin at 8:00pm.

# Dee Mosbacher, MD, Ph.D., accepts the 2014 AGLP John Fryer Award

Dee Mosbacher, M.D., Ph.D., psychiatrist, film-maker, and activist for women's and gay rights, will receive the John E. Fryer Award from the American Psychiatric Association (APA) at their annual IPS meetings in October in San Francisco. The award is presented by the APA in association with the Association of Gay and Lesbian Psychiatrists and given in honor of Dr. John Fryer, a gay psychiatrist who played a crucial role in prompting the American Psychiatric Association to review the scientific data and to remove homosexuality from the APA's diagnostic list of mental disorders in 1973.

Dr. Mosbacher founded Woman Vision, a nonprofit aimed at promoting tolerance and equal treatment of all people, in 1993. Through Woman Vision, Mosbacher has produced nine documentary films dealing with women's and LGBT rights. Straight from the Heart (1994), directed and produced by Mosbacher, portrays parents' love and acceptance of their gay children, and was nominated for an Academy Award. All God's Children (1996) deals with gays and lesbians in the black church, and the stiamatization of homosexuality in the African American community. No Secret Anymore (2006) chronicles the life and love affair between gay activists Del Martin and Phyllis Lyon, and Training Rules (2009) explores the issue of homophobia in college sports.

In 2012, Woman Vision launched a project called The Last Closet, a web-based campaign and video project to end anti-gay bias in men's professional sports.

Dee Mosbacher's 1985 documentary, Closets are Health Hazards: Gay and Lesbian Physicians Come Out, was remarkable at the time, as many fewer physicians were able to be open in their lives and work, and the general public did not associate the words "gay" and "physician." She followed this up with the 1991 film Lesbian Physicians on Practice, Patients, and Power, largely filmed at a Women in Medicine conference.

Dee Mosbacher lives in San Francisco with her wife of many years, psychiatrist Nanette Gartrell.

Created by AGLP in 2006, The John E Fryer, MD Award honors an individual whose work has contributed to the mental health of sexual minorities. The award was endowed through a generous grant from the Gill Foundation, a bequest from the estate of psychiatrist Frank Rundle, and contributions from many AGLP members. Other past awardees include Barbara Gittings and Franklin Kameny; Past APA President Laurence Hartmann; Psychiatrist and Researcher Richard Pillard; San Francisco Mayor Gavin Newsome; LGBT activist Evan Wolfson; and Bishop Gene Robinson, and Caitlin Ryan.

# The Assembly Allied Organizations and Sections Liaisons (AAOSL) Report

In 2006 I became the first AGLP liaison to the Assembly (legislature) of the APA. I have had the privilege of sponsoring and/or being directly involved in legislation on behalf of AGLP that put the APA on record as supporting gay marriage, opposing the don't ask/don't tell policy in the military, decrying the death penalty for homosexual behavior in Uganda, and in writing the APA's recent comprehensive and far-reaching position statement on LGB matters. I have also had the honor of being nominated twice by my colleagues to become the speaker of the Assembly, which is its presiding officer, albeit not elected. I however have been elected as the chair of the allied organizations committee (the AAOSL Committee), and, in that role, give AGLP a presence on the Executive Committee of the

Assembly. Providing our President and Executive Board continue to grant me the privilege of being AGLP's representative, in 2016 I will have been in the Assembly for 10 years. It will then be time for someone new to take the mantle.

the Assembly and to two local Area meetings. Functionally, both for myself and other small allied organizations, those expenses become a personal expense for the liaison. In the long run, it is a small price to pay for the opportunities that come with serving and feeling like one can make a difference in what the APA does.

The Assembly represents the 35,000 members of the American Psychiatric Association, which is the largest psychiatric organization in the world and has an annual budget of over \$50 million. We like to think of the APA as a member organization. In actuality, it is not. The APA is a corporation that is in essence owned and run by the Board of Trustees. Members can choose to be part of the APA, or not, but have no direct say on what the APA does or how it is structured. That is why the trustees of the Board stop representing the members that elected them to the Board the moment that they become a member of the Board of Trustees. Board members represent the Corporation, not members. Although there is a procedure for members intervening and forcing the Board of Trustees to reverse or take a particular position (providing that position does not represent a fiduciary risk to the Corporation), that procedure has such a high bar that, functionally, it is vacuous. There simply is no way that a referendum can get the minimum 40% of members to vote in this day and age with the massive size of the APA and all of the competing demands on members' time and attention. Officers of the APA are generally elected by between 20% and 30% of the membership and no referendum in recent history has gone beyond 30% — even the most recent one which had members up in arms about the new complex and onerous maintenance of certification requirements coming out of the American Board of Neurology and Psychiatry which seem to be tacitly supported by the Board. The Assembly provides representation from the members to advise the Board, but ultimately, has no powers other than what the Board grants.

We like to think of the APA as a member organization. In actuality, it is not. The APA is a corporation that is in essence owned and run by the Board of Trustees. Members can choose to be part of the APA, or not, but have no direct say on what the APA does or how it is structured.

It takes four or five years for an Assembly representative to truly understand how the Assembly works. I want to use my article for this issue of the Newsletter to describe some of the lessons I have learned over the last eight years to give readers an insight into the APA and how it interacts with the Assembly with the hope that it will pique the interest of one of our members who will be willing to make the long-term commitment to take over where I will leave off.

The Assembly of the APA

AGLP had always had an indirect presence in the Assembly through the LGB minority/ underrepresented (M/UR) representative, but that representative actually represents the LGB Caucus which is part of the APA and under its rubric. Years ago, the president of AGLP was automatically made president of the APA Caucus. With the advent of the Assembly liaison position for allied organizations, the two positions are now held by different people and the Caucus and AGLP are separate. The one major difference for the new allied organization liaisons, however, was that the allied organizations were expected to bear the travel and lodging costs of their liaisons to the two annual plenary sessions of

The basic structure of the Assembly is geographically centered on district branches. The 70+ district branches are grouped together into seven geographic regions, called Areas. Each district branch sends a representative to the Assembly based on the number of members in the district branch (one representative for every 450 members). The district branch representatives within an

Area elect an Area Representative and Deputy Area Representative. The Area Representative presides over the meetings of the Area during the November and May meetings of the Assembly and also at two local Area meetings in preparation for the Assembly. The Area Representative and Deputy Representative also serve on the Executive Committee of the Assembly — which is where much of the power is centered in the Assembly.

Because there are many minority interest groups which would not have enough members within a district branch to dominate the branch and thereby be able to send a representative with their preferences to the Assembly, a matrix of collateral representatives have been added to the Assembly to insure that those interests are represented. Each Area sends a representative and deputy representative for Early Career Psychiatrists and for Resident Fellows (formerly called members-in-training). These two collateral groups elect a chair and vice chair. The chair sits on the Assembly Executive Committee. The minority/underrepresented group (M/UR) is composed of representatives from each of the minority caucuses. Each of these caucuses can send a representative and a deputy representative to the Assembly. The chair of the M/UR committee sits on the

Assembly Executive Committee. Finally, psychiatric organizations allied with the APA (i.e., outside the APA) and sections (i.e., special interest groups within the APA) are allowed to send liaisons (AAOSL's) to serve in the Assembly. AGLP is one of the 19 allied organizations and sections. The chair of AAOSL committee sits on the Assembly Executive Committee. All of the collateral representatives are assigned to the Area in which the representative resides. Attendance at the local Area meetings is a necessity to fully participate in the Assembly.

Every year, the Assembly elects its presiding officer, the Speaker-Elect, who one year later presides over the Plenary and guides the Assembly as the Speaker. It also elects a Recorder who tracks action papers and certifies representatives. All three officers: the Speaker-Elect, the Speaker, and the Recorder, have specific duties. These officers are the only Assembly members who are paid a stipend for their duties. All other Assembly members receive travel and lodging reimbursement except for the AAOSL's. Food is provided to everyone at APA expense.

The Assembly makes its positions known primarily through legislation, called "action papers." Any representative can write an action paper. Given the almost 200 personalities who are involved in the Assembly, action papers range from the pertinent to the arcane. To help weed out and refine the action papers, every action paper is submitted to a Reference Committee. Every Area and each of the collateral groups send a representative to each of the five Reference Committees. There thus are 11 members on a Reference Committee. one of whom is appointed chair by the speaker. The Reference Committees hold hearings on action papers before action papers go to the floor of the Assembly in the Plenary and work with the author to refine the action paper. The reference committee then recommends to the Assembly that the action paper be past, rejected, or modified as recommended by the Reference Committee. Any Reference Committee's changes are given preference and are heard first. The author optionally may move the paper to be passed as written. More often than not, the Assembly follows the recommendations of the Reference Committee.

Once an action paper is brought to the Plenary, the action paper is debated briefly using Sturgis Parliamentary Procedure, and then voted upon. Most votes are done by voice. Under that circumstance, each representative is accorded a single vote. All representatives are equal. If there is a question about the vote count, a standing vote can be called in which votes are actually counted. If six representatives from at least two different Areas call for a Vote by Strength, a Vote by Strength is compelled. In a Vote by Strength, the district branch representatives each are given one vote for every member they represent. The Area Representatives, Deputy Area Representatives, and all the collateral group representatives are each given only one vote apiece. By way of example, a New York district branch representative may cast as many as 450 votes on a matter while an early career psychiatrist representative for Area 2 casts only one vote. In all, the district branch representatives have about 30,000+ votes while all the collateral groups together have a total of about 42 votes. A Vote by Strength in essence disenfranchises everyone except a geographic representative. Most votes are not done by strength because they are time-consuming and difficult to do. There is a move within the Assembly to institute electronic voting which would make Vote by Strength easy to do, causing the collateral representatives some alarm. Officers of the Assembly are elected in a Vote by Strenath.

Once an action paper is past, it is sent to the Joint Reference Committee, which is composed of representatives from the Board of Trustees and the Assembly. The APA President-elect serves as chair and the Assembly Speaker-Elect serves as co-chair. Action papers that are modified, in essence, by a massive committee called the Assembly, sometimes leave the JRC scratching its head trying to figure out how to implement the paper. The JRC may choose to simply table the action paper and it ends there. More typically, the action paper is sent to a Council for revision and recommendations for implementation. Councils report to the Board of Trustees with members appointed by the president of the APA. Once a Council has worked out a plan for implementation, the action paper is generally sent back to the Joint Reference Committee which typically sends it to the Board of Trustees. The Board of Trustees may choose to accept the work of the Council — or not, or ask that it be modified. More than one action paper has been nixed by the Board of Trustees.

In short, getting an action paper through the APA is protracted, convoluted, and difficult because so many voices need to be heard. A representative cannot succeed without developing coalitions with other members. It is for that reason that, even though I represent LGB matters in the Assembly, I have been involved in a wide variety of unrelated issues (such as the maintenance of certification problem). The alliances that I make in working with members on their favorite legislation prove valuable later when I want to move issues related to LGB matters. Those coalitions take time. The longer one is in the Assembly, the stronger those coalitions become. What I would like to do in the following two years is to have my replacement shadow me to be introduced to the process thereby shortening the learning curve and fostering the coalitions that are necessary to have any true influence in the Assembly. Any member who might be interested in taking on this role should contact Dr. Kenneth Ashley, the president of AGLP, to express an interest in the position

Let me close by stating how much I appreciate and have benefited from AGLP's willingness to have me as its representative. It has defined much of my life over the last eight years.


