AGLP 2021 Awards

Our AGLP 2021 Awards recognise people and organizations mostly located in the Los Angeles area this year. The Committee focused on this locale since the original location of the APA Annual Meeting was to be hosted by this city.

The AGLP James Paulsen Award, created in 1986 and presented to an AGLP member who has made significant contributions to the ongoing life of the organization, is conferred this year on Howard Rubin, M.D., a long-standing member of AGLP. In addition to his role as President of AGLP, substantial contributions to the Education Committee over the past year, contributions to the Journal, and sustained patron support, he continues to vitalize and invigorate the mission of AGLP and support the LGBTQ community at-large.

The Barbara Gittings Award for 2021 is being presented to Sheila Kuehl. The AGLP Barbara Gittings Award is presented to a woman who demonstrates exceptional leadership and advocacy for Lesbian Issues. It was named after one of the founders of the gay rights movement and one of the activists instrumental in moving APA to consider depathologizing homosexuality. Ms. Kuehl's leadership, particularly as an openly gay elected official, has set an example for many LGBTQ+ community members. Her anti-discrimination legislation, on the basis of gender and disability in the workplace and sexual orientation in education, lifts up measures that begin to address our in-common mission: to educate and advocate for best mental health practices for our community.

The **Distinguished Service Award**, AGLP's first designated award, is given to an individual for outstanding contributions to the LGBTQ community. Over the years it has been awarded to AGLP members whose work extends past the reach of the

ello everyone. I am writing to you just after finishing the recording of my talk about LGBTQ Health Policy, which will be broadcast during the Annual Meeting and followed by a live discussion and Q&A. I discussed Marriage Equality, and I was joined by Dr. Jack Drescher and Dr. Saul Levin, as well as Cathy Renna. They were discussing other topics of relevance to our community in politics these days, including Religious Liberty Laws and the Affordable Care Act's section 1557 (which details non-discrimination). We felt these were very important topics to cover at this time, seeing as we have a more liberal administration but a more conservative Supreme Court than before. This will lead to the so-called "culture wars" continuing, and sadly LGBTQ individuals are at the heart of that battle once again.

In addition to Marriage Equality being legally challenged in many states, in hopes that this Supreme Court would take up a case and reverse their 2015 decision, we have all heard about the bans on transgender athletes and the aforementioned "Religious Liberty" bills. In addition, there is a concerted effort to restrict voting rights throughout the country, but particularly in the states narrowly won by Joe Biden or ones with heavy minority populations. Naturally, this affects LGBTQ people disproportionately as well, since many members of our community, especially members of color, are less likely to have an ID to show at the polls and are less likely to be able to get time off of work or transportation to cast their ballots. Of course, even requiring an ID is a huge barrier for the Trans* population given the difficulties in aettina legal name changes and having matchina ID. This can lead to these individuals being turned away from voting centers or flagged for fraud incorrectly.

So, I write to you all to say that our work is far from over. In 2008, after the election of Barack Obama, many of my friends went "back to brunch" as the news pundits like to say. I

also became complacent, thinking that progress was inevitable. Well, we were all wrong, and under our noses arose a righteous anger from the downtrodden in our country. They were sick of being left out of the American conversation and their lives

were just getting worse, even as the overall economy boomed. The Right provided a channel for the anger, and unfortunately for us and for our mission, it was targeted at "the other," where it so frequently lands. That included African-Americans, Latinx people, Native Americans, Asian-Americans, and also LGBTQ Americans (among others). We cannot let this fester, as it is a virus that is growing in strength and showing up in more violent ways every

Let us continue this great work that we are doing. Please consider getting more involved in AGLP and helping us with educational sessions. Amicus Briefs, and our new Policy and Advocacy Committee. We all must do our part to help social progress along. and to make this a fairer and more just country for everyone.

2021 John Fryer, M.D., Award Winner



Malcolm Lazin

Malcolm Lazin has been named the winner of the 2021 John E. Fryer, M.D., Award. The award honors an important and highly-visible figure in the LGBTQ-rights community and offers opportunities for another voice in the ongoing advocacy for rights, research, and informed care for our LGBTQ patients. Mr. Lazin will receive this award and make his virtual presentation, "John Fryer, M.D. American Civil Rights Icon: How the APA Bent the Arc of Justice," on Saturday, May 01, 2021, at 2:00pm.

Malcolm L. Lazin is an American social activist, prosecutor, entrepreneur and educator. His endeavors include Lesbian, Gay, Bisexual and Transgender (LGBT) civil rights, federal and state law enforcement, developing Philadelphia's waterfront, lighting the Benjamin Franklin Bridge and incorporating

Washington Square—the largest revolutionary war burial ground—into Independence National Historical Park.

After fulfilling active training in the U.S. Army reserves, Lazin began his career in 1969 at the U.S. Department of Housing and Urban Development (HUD) in the Philadelphia regional office. He went on to become an Assistant United States Attorney for the Eastern District of Pennsylvania from 1970-1974.

In 1973, Lazin left the U.S. Attorney's Office to enter private practice as a litigation associate. Two years later, he accepted a partnership at Fell Spaulding Goff & Rubin, a Philadelphia law firm.

In 1978, Pennsylvania governor Dick Thornburgh named Lazin a leader of his gubernatorial campaign. Lazin "played a key role in the campaign." Under the Thornburgh administration, Lazin served as the volunteer Pennsylvania co-chair for the International Year of the Child. With the first lady of state, Ginny Thornburgh, Lazin successfully lobbied to make Pennsylvania the first state to mandate child automobile safety seats.

Lazin is the founder of Equality Forum (a national and international LGBT civil rights organization headquartered in Philadelphia) and LGBT History Month. As Vince Bellino explains, "Equality Forum has, for the last decade, organized LGBT History Month, which honors 31 icons of the movement each year." Lazin is also the executive producer of three award-winning documentary films and an Off-Broadway play.

Lazin has received the U.S. Attorney General's Distinguished Service Award (the Department of Justice's highest honor); the Creative Leadership in Human Rights Award from the National Education Association; the Lifetime Hero Award of the Delaware Valley Legacy Fund; and is a Prime Mover of the Hunt Alternatives Fund. He serves as an adjunct professor at the New College of Florida and an Emeritus Trustee of Lebanon Valley College. He has presented lectures on LGBT civil rights at high schools, colleges, and national meetings in the United States and Canada.

The John E. Fryer, MD, Award honors an individual whose work has contributed to the mental health of sexual minorities. It was named for John Fryer, the psychiatrist who appeared as "Dr. H. Anonymous" at the 1972 APA meeting and helped move forward the process of removing the diagnosis of homosexuality from the DSM. The Award was funded by AGLP members, a matching grant from the Gill Foundation, and a bequest from AGLP founding member Frank Rundle, MD.

AGLP continues drive to develop the John Fryer, MD, Award

The Association of Gay and Lesbian Psychiatrists (AGLP) has instituted a fund raising campaign, in association with the American Psychiatric Foundation, to help to further endow this award in perpetuity. The Fryer Award lecture educates psychiatrists on a wide range of significant LGBTQ issues. These lectures take place at the Annual Meeting of the American Psychiatric Association (APA) and are popular and well-attended. By publishing these lectures as papers in the Journal of Gay & Lesbian Mental Health, which has a wide circulation among psychiatrists and other mental health workers, the reach of these lectures is extended even further. Past honorees have included prominent advocates for the LGBTQ community, such as Barbara Gittings, Frank Kameny, Gavin Newsome, Evan Wolfson, and Bishop Gene Robinson, as well as experts in psychiatry and the mental health field, including Lawrence Hartmann, Richard Pillard, Marjorie Hill, Dee Mosbacher, Jack Drescher, and Caitlin Ryan.

The award is named for John Fryer, M.D., the Philadelphia-area psychiatrist, who appeared with Barbara Gittings and Frank Kameny as "Dr. H. Anonymous" at the 1972 APA Annual Meeting and helped move forward the process of removing the diagnosis of homosexuality from the DSM. John Fryer, MD was born in Kentucky in 1938. He attended medical school at Vanderbilt University and completed his psychiatry residency in Philadelphia and spent the rest of his career in Philadelphia. His early years as a psychiatrist were difficult because of his sexual identity. He was forced to leave the University of Pennsylvania's Psychiatry Residency Program when it was discovered that he was gay, and later he completed his residency at Norristown State Hospital. Dr. Fryer was never apologetic about who he was or how he presented himself, and he went on to have a distinguished career as a professor of family and community psychiatry at Temple University.

GLP's Committee on Legal Advocacy has developing a set of position statements for AGLP which define AGLP's values, scientific understanding, and beliefs about current LGBTQ+ issues for the benefit of the public which may choose to reference AGLP's expertise. The position statements are developed by the Committee and sent to AGLP's Executive Board for approval, modification, or rejection. The Committee is currently chaired by Dr. David Scasta and includes AGLP president, Dr. Amir Ahuja, and (soon to be Dr.) Jay Loiuk (a graduating medical student), with guidance from AGLP's Executive Director, Mr. Roy Harker. Other participants on the committee are welcome. The following position statements have been approved by AGLP's Executive Board. Comments or questions or desire to participate on the committee can be referred to Mr. Harker (rharker@aglp.org).

Position against Exclusion of Transgender People in the Military

AGLP: The Association of LGBTQ+ Psychiatrists, recognizes and lauds the many sacrifices transgender military veterans and active-duty service members have made to protect the security of the United States. AGLP opposes the "2018 Presidential Memorandum for the Secretary of Defense and the Secretary of Homeland Security Regarding Military Service by Transgender Individuals" (DoD Instruction 1300.28) barring transgender individuals from enlistment in the United States Arm Forces. It is the position of AGLP that a transgender identity does not, per se, impair an individual's ability to serve as a member of the United States Armed Forces. The arbitrary exclusion of transgender individuals from the United States Armed Forces serves to exacerbate historical discriminatory stigmatization of transgender individuals and contributes to the negative mental health consequences that follow such stigmatization.

AGLP's Statement on Protection against Discrimination on Health Care

AGLP: The Association of LGBTQ+ Psychiatrists, opposes discrimination against LGBTQ+ (Lesbian, Gay, Bisexual, Transgender, Queer, etc.) individuals based on religious proscriptions, bigotry, or lack of comfort in dealing with LGBTQ+ individuals. AGLP opposes efforts by the United States Department of Health and Human Services to remove protections against discrimination in the provision of health

services to LGBTQ+ individuals because of gender, gender identity, or sexual orientation based on religious proscriptions. The scientific study cited by the United States of Department of Health and Human Services with regard to transgender individuals did not justify its conclusions that discrimination is warranted. It is the position of the AGLP, as experts in the provision of mental health care to LGBTQ+ individuals, that discrimination in the provision of health care to all individuals, for whatever justification, is improper and harmful.

AGLP's Statement on the Removal of Diversity Training in Federal Agencies

The Association of LGBTQ+ Psychiatrists, opposes the recent Executive Order "Executive Order on Combating Race and Sex Stereotyping" that was issued on September 22, 2020. AGLP is committed to diversity and to the mental health of LGBTQ+ Psychiatrists as well as LGBTQ+ Patients. It is the position of this organization that this Executive Order is harmful to all LGBTQ+ people, and particularly LGBTQ+ people of color, and runs counter to our mission.

AGLP Statement on Combating White Supremacy in the United States

AGLP: The Association of LGBTQ+ Psychiatrists, recognizes the intersectionality of race, ethnicity, and sexual and/or gender identity. We therefore acknowledge that the continued existence of white supremacy beliefs within the United States threatens the physical and mental well-being of many of the patients we serve, including LGBTQ+ identified individuals. AGLP is disheartened by continued violence towards people of color in this country. AGLP also acknowledges that recent acts of violence towards non-white individuals are a reflection of more ubiquitous forms of systemic oppression that are deeply engrained in this country's history and present environment. AGLP strongly opposes and publicly condemns white supremacy ideology in all forms, acknowledges the profound negative mental health impacts of said forces, and calls upon the medical community to genuinely invest its resources and training towards combating racism and implicit racial biases.

AGLP Statement on Combating the rise of Anti-trans legislation in the United States

AGLP: The Association of LGBTQ+ Psychiatrists, recognizes the unprecedented surge of discriminatory legislation targeting transgender and gender non-conforming identified individuals. By March of 2021 a total of 82 discriminatory anti-trans bills have been introduced in state legislatures across the country, marking a new and disheartening record. These radical proposed laws are widely unpopular according to multiple surveys, harmful, and plainly not evidenced based. Bills, ranging from attempts to impede access to healthcare to barring the use of gender-aligned bathroom facilities, jeopardize the physical well-being of transgender patients across the country. Irrespective of such proposed legislation, the propagation and normalization of

AGLP strongly opposes the introduction and enactment of legislation that adversely targets the transgender and gender non-conforming community, and calls upon the medical community to both recognize and combat this ongoing crisis.






