New Orleans is and is not the city you remember. We still know how to entertain. We're the perfect convention city and remain entirely welcoming of LGBT visitors. We have more restaurants than before Katrina, and just about every place where you remember dancing, singing, and eating is open and thriving. The Annual Meeting is one day shorter than before, and most AGLP members will find that this special time will come and go very quickly. A glance at this Newsletter will tell you that the meeting is rich with opportunities to learn, and to make and revive friendships.

A shorter meeting will make it harder to get out and about, but you will be rewarded if you do. hen my buddies suggested a trip to New Orleans for Thanksgiving, I remember thinking that it was inspired. Time being what it is I didn't get to see much of them even though they only live a few blocks away. And it was a chance to see a place that I only knew obliquely through the worlds of Truman Capote and Tennessee Williams. Beyond that I'm not sure what I expected.

What I found was a city which was an anomaly in the United States; a truly unique place. If it is possible to say that poverty can have positive effects; it seemed that because of the economics in New Orleans, it had been spared the *Starbuckification* which characterizes so much of America. Major corporations that dominate the urban fabric of most cities had turned their backs on New Orleans. This seemed to allow the city continued to have a strong connection to its disparate roots creating an authentic sense of place. Truly unique, unvarnished and about as real as it gets.

Like San Francisco, there were areas of the city seemingly presented for the benefit of tourist while leaving the rest of the city to carry on with daily living. Moving in any

direction away from the Central Business District revealed a wide variety of distinct neighborhoods each with something different to offer. Traveling by foot wasn't always practical but constantly rewarding as the homes and buildings all seem unique while sharing an architectural vernacular. And anyway, how can you not fall in love with a city that has neighborhoods with such evocative names: Faubourg Marigny, Tremé, or Bayou St. John.

The cuisine of New Orleans was as homegrown as the streetscapes. The basis of these foods was true to the heritage

I feel confident that what I found refreshingly different will be there still and that I'll once again be invited to take it easy and enjoy the sweetness of the moment.

he plans for New Orleans AGLP are close to completion. Everyone should pay close attention to the schedules of both AGLP and APA, as there have been some changes. Roy has made reference to the changes on the AGLP schedule in his recent columns.

The symposium of mental health issues in LGBT elders should be interesting and informative. In October, 2009, the federal government increased focus on this very issue when the Department of Health and Human Services (HHS) announced creation of a National Resource Center for Lesbian, Gay, Bisexual and Transgender Elders.

The federal government has also been able to make other significant changes in healthcare for

all Americans—including members of the LGBT community, with the passage of healthcare reform legislation. The details of the legislation remain to be hammered out, but it is hopefully a step in the right direction—even if there is not a public option. It is interesting how the idea of providing healthcare to most Americans has been so divisive, even in the medical community.

Most recently, President Obama sent a memorandum to the Secretary of Health and Human Services to establish a rule "Respecting the Rights of Hospital Patients to Receive Visitors and to Designate Surrogate Decision Makers for Medical Emergencies." While this issue does have particular significance for the LGBT community, the media spin has ignored how this affects all Americans.

I understand the need for the changes that should be enacted by HHS following President Obama's memo, but I don't see it as directly affecting the policies at the hospital I work at in New York City, already having similar regulations in place. More importantly in March of this year the Family Health Care Decisions Act was signed by Governor Paterson, focused on determining who can make health care decisions, including decisions about the withholding or withdrawal of lifesustaining treatment, on the behalf of patients who lose their ability to make such decisions and have not prepared advance directives regarding their wishes.

One significant change was the addition of domestic partner (either homosexual or heterosexual) to the ranked list of individuals who may make such decisions. Domestic partners were included in the order of priority comparable to married partners, whereas previously they could only be considered "close friends" which was the lowest priority—below adult son or daughter, parent, adult brother or sister.

As a member of my institution's Ethics Service, I was dreading the day that I was called to a case involving a gay man or lesbian without advanced directives, where the family and the patient's partner did not agree on the medical management of the patient. Legally, the partner (considered a "close friend") would be lowest priority, requiring that the other family members be allowed to make the medical decisions. With this new legislation, while there may be such disagreements about treatment among family members, it is the domestic partner who will have priority, now having the same status as a married partner. I know that

the hospital is currently updating the policies and procedures manuals, in accordance with the new law. I am hoping that everything is in place when I am on Ethics Consults next week.

#### **Distinguished Service Award**

AGLP's annual Distinguished Service Award is presented to an individual whose body of work or activities has promoted the mental health of the GLBT community in an extraordinary way. We are honored to announce that the recipient of this year's Distinguished Service Award is **Roger Peele**. MD.

It would be safe to say the Roger is one of the most respected and accomplished members of the APA serving in numerous roles within the APA governance for more than 30 years when he first joined the Assembly. He has served as speaker of

the Assembly, a member of the APA Board of Trustees, a member of the Washington Psychiatric Society Board of Directors and a member of the task forces for DSM —IIIR, DSM-IV, and now DSM-V. Roger is the Chief Psychiatrist of Montgomery County Maryland, and is a Clinical Professor of Psychiatry at George Washington University.

Through all of this, Roger has been one the strongest and most vocal supporter of LGBT mental health issues. He has been instrumental in the passage of important LGBT-related action papers and position statements such as the position statements on Reparative Therapy and Same-Sex Civil Unions. More than just vocally supporting LGBT issues, Roger has backed this up year after year through his long-standing membership in AGLP.

#### **James Paulsen Award**

The Paulsen Award is given annually to "one of our own" to honor an individual for their outstanding contributions to AGLP. This year's most deserving recipient is **Mark Townsend, MD**.

Mark has once again provided remarkable leadership for the New Orleans local arrangements committee as he has numerous times previously dating back to when he was a psychiatry resident. Mark has also served as Secretary of AGLP and was the author of one of the first major updates and revisions of AGLP's bylaws. He has served for many years the representative to the APA Assembly of the Caucus of Lesbian, Gay and Bisexual Psychiatrists and is currently the chair of

the Assembly's Committee of Minority and Underrepresented (MUR) groups. Mark is the Vice Chair for General Adult Psychiatry at the LSU Health Science Center. Mark lives in New Orleans with his partner, Jeff Lockman, and their teenage son, Ben. Mark is currently studying for his Bar Mitzvah.

#### Stuart Nichols Award

The Nichols Award was created to honor a program or agency in the city where the annual meeting is being held which provides mental health or related services primarily to the LGBT community. Dr. Nichols was a founder and the second president of AGLP. He was also instrumental in forming Gay and Lesbian Psychiatrists of New York. He was the first

chairman of the national APA AIDS Commission and along with Bert Schaffner ran a support group for HIV-positive physicians for many years. As Medical Director of Beth Israel's Methadone Maintenance Program (comprised of 24 clinics), Stu was a strong advocate of community mental health.

The New Orleans local arrangements committee has selected the **New Orleans AIDS Task Force** as this year's recipient of the Nichols Award. Founded in 1983, NO/AIDS Task Force is one of the oldest and largest AIDS service organizations in the Gulf South providing hope, care, and dignity to men, women, and families affected by HIV/AIDS. The NO/AIDS Task Force was founded in response to the devastating effect was having in New Orleans particularly among the LGBT community. Early services included a hotline and community outreach, condom distribution, a buddy system, and HIV antibody testing and counseling. Case management and substance abuse and mental health services were added in 1990. These services plus many others that have been added over the years help the NO/AIDS Task Force achieve its mission to reduce the spread of HIV, provide services, advocate empowerment, safeguard the rights and dignity of HIV-affected individuals, and enlighten the public. **Noel Twilbeck**, the executive director of the NO/AIDS Task Force, will be on hand to accept the Nichols Award.

#### **Barbara Gittings Award**

This award is the newest addition to AGLP's roster and was created in honor of Barbara Gittings, a true pioneer of Lesbian and Gay activism. She was instrumental in pushing forward the declassification of homosexuality as a mental illness by the psychiatric profession. She was also very active with the American Library Association in making sure that LGBT literature was available and accessible to the public. The award is given to any woman, AGLP member or not, psychiatrist or not, who has contributed significantly to LGBT Mental Health. This year's winner is Joanne (Jody) Gates, MD.

Jody is a retired Pediatric Pulmonologist in New Orleans who was quite closeted until she learned that patients and staff knew her as the "Dyke Doc." That led her to get involved with medical LGBT groups. She went on to leadership roles on the board of GLMA and the Women in Medicine Group. Those experiences in turn inspired to find her voice in local politics in New Orleans, first with the Forum for Equality, a local PAC working for LGBT Equality in New Orleans and Louisiana and then with the Human Rights Campaign where she now serves as the Female Co-Chair of the Major Donor Committee of the Board of Directors.

She has also participated, along with Mark Townsend, in panel presentations about LGBT health issues to the medical students at both Tulane and LSU.

Jody is involved with a 20 year old Lesbian Discussion and Empowerment Group known as the Mamou Riding Club. The group keeps each other informed about local and national political issues. They also work on helping each other be happy out of the closet and in developing stronger friendships and close relationships.


