Oshiro spearheaded the recent passage of a Same-Sex Civil Unions law in Hawaii. y tenure as Editor of the Newsletter is an embodiment of the old saying, "No good deed goes unpunished." In 2003, I'd edited the Annual Meeting Pink Shrink Guide for the San Francisco Local Arrangements Committee (SFLAC). It was a bigger project than I thought it would be, but luckily it was a one time deal. What was great was how nice it looked when Roy got done with it. I still have a copy on my shelf.

When it was announced that Cheryl Chessick was stepping down as Editor, Ellen Haller, who had worked with me on the SFLAC, approached me about taking on the Newsletter. I did my best to avoid saying yes as it seemed like it would be like putting together a Pink Shrink every three months. But I eventually found I didn't have any good reasons to say no and I signed on.

Cheryl got me started with a blue print of what each of the quarterly editions looked like and some tips on how to bring it together. I headed to New York for the 2004 Annual Meetings which would be the substance of the first edition on my watch. That first year was a learning process, which was particularly challenging as it was so public. I figured it would be easier the next go around and was mainly correct about that.

As the years have stretched on there have been some changes; of process, personnel and my comfort in the role. Something fundamental has shifted about the way we expect to have communication. The Newsletter runs at a relative glacial pace occurring only four times a year compared to minute to minute updates on your Facebook page.

Reflecting on significant developments during my past five years of service for AGLP, I am happy to say that our hopes and expectations regarding the battle for LGBT equal rights have been rewarded with some degree of progress, particularly since the election of President Barack Obama. Although we have yet to achieve full victory, we have reasons to rejoice that the unjust and hideous "Don't Ask, Don't Tell" military policy, which penalized valorous LGBT individual's ready to fight for our country, has been repealed. Even though marriage between persons of the same sex has not yet been federally recognized, the President's recent Executive Order to cease defending the federal policy sanctioning marriage as an institution legally recognized only between a man and a woman is encouraging; I am confident that it is the first step towards the legalization of homosexual marriage. Other developments on the horizon, such as health care reform, are more difficult to gauge, but this is just part the struggle in which we are enmeshed. These and other advances in human rights are part of the hopes that were sparked by Mr. Obama's election.

Despite witnessing the undeniable progress towards achievement of equal rights for LGBT individuals, we cannot ignore the multitude of problems of a global magnitude which challenging all of us, not just as LGBT individuals, but as human beings. Of late, Nature's heavy hand has resulted in a variety of major catastrophes, including the array of devastating earthquakes that shook the world only weeks ago. Human greed and prejudice continues to stir wars and environmental disasters even as I write.

All of these things demands continued concern, involvement, cooperation and generosity. United as LGBT psychiatrists, we can maintain our hopes for a healthier, better world. To achieve this, we contribute everyday through our work to heal illness, open minds, educate mental health professionals and the public at large, and support the oppressed minority groups to which we belong.

#### **News from the Basement**

Maintenance of Certification (MOC)

The Assembly has been quite active over the last several months. I had the opportunity to be the lead author of two Action Papers (AP), cosigned by 22 Assembly Representatives, on the new American Board of Psychiatry and Neurology's (ABPN) Maintenance of Certification requirements. If you get a chance, go to the ABPN website and check out what will be required of psychiatrists to continue to list themselves as "Board Certified." The requirements, as initially described, demand a substantial investment of time — and money.

One of the requirements that I felt was particularly egregious was the requirement of solicitation of patient feedback. Psychiatrists would be required by the third year of the 10 year cycle of recertification to solicit feedback from five patients, develop an action plan to address the problems revealed by the feedback, and then by the sixth year solicit feedback from five more patients to ascertain if corrective action was effective. One of our AP's called for the APA to denounce the use of patient solicitation of feedback as a criterion for MOC, based on the conviction that such solicitation contaminates the therapeutic process leading to grooming of patients for the benefit of the psychiatrist's feedback. The APA staff submitted the AP to the Ethics Committee and reported that the Committee found no ethics violation in soliciting patient feedback. When I complained that the Ethics Committee had been given a solitary view of the issue, I was informed that it is improper for members of the APA to present arguments on an ethics issue which is before the Committee. The second AP called on the APA to explore the possibility of setting up its own separate recertification board.

Our two Action Papers went to the Reference Committee 4, headed by Dr. Eric Plakun, who spoke out strongly in favor of patient solicitation. The Reference Committee elected to scrap both Action Papers and instead recommend a taskforce to explore the ramifications of the MOC requirements. We agreed to accept the Reference Committee's recommendation but elected to still bring the Action Paper on patient solicitation to the plenary floor. That Action Paper was defeated based on Dr. Plakun's eloquent plea to allow the taskforce time to deliberate and come back to the Assembly with its recommendations. President Carol Bernstein appointed Mary Helen Davis from the BOT (Board of Trustees) as chair of the taskforce. Dr. Plakun also was appointed to the taskforce. As best I know, the taskforce does not have one person on it who opposes patient solicitation. Dr. Plakun suggested to me that the probable reason that the taskforce does not have anyone on it who opposes patient solicitation is because the Ethics Committee has already ruled on such.

In the meantime, Dr. Ramaswamy (Vis) Viswanathan, an Area II representative, initiated a referendum calling on the APA to oppose the ABPN requirements. I think it is fair to say that there was little support for the referendum among much of the APA leadership. Vis had difficulty finding a venue to get his message out to APA members about the issues that were behind the refer-

endum. Dr. Robinowitz, the interim Psychiatric News editor, at least initially, was reluctant to discuss the issue publicly in Psychiatric News, preferring a negotiated resolution. Vis was able to gather just short of 800 signatures to force the referendum on the ballot. (500 were needed.) One of the past presidents of the APA reportedly demanded that the referendum be reworded to correct what she saw as misinformation. The BOT correctly opined that a referendum from the membership cannot be modified by the BOT. In the latter half of the voting period, both Vis and I were able to get letters to the editor published in Psychiatric News regarding the referendum. Dr. Robinowitz accepted my letter only on the condition that I eliminate a paragraph regarding the predominance of psychiatrists from academia in the leadership — which may lead to a more pedantic stance that might not be in touch with the experiences of the rank-and-file working out in the trenches.

A stunning 80% of the membership that voted supported the referendum. The referendum however failed on technical grounds because only 25% of the membership voted. A minimum of 40% would have had to have voted and a minimum of 33% of the entire membership would have had to have been in favor of the referendum for it to pass. The referendum called upon the APA to inform the ABPN that:

- 1) The patient feedback requirements for the purpose of reporting to the Board are unacceptable, as it creates ethical conflicts, and has the potential to damage treatment.
- 2) The requirements other than a cognitive knowledge examination once in 10 years, regular participation in continuing medical education, and maintenance of licensure, pose undue and unnecessary burden on psychiatrists.

VOTE: 5525 in favor, 1418 opposed.

As the issue unfolded, the patient solicitation requirement kept getting redefined to the point that the requirement now is simply to hand out five brief, single-page questionnaires that asks for check-off responses to a dozen general questions such as whether the therapist listens to the patient. The questionnaires are to be seen only by the applicant but the applicant must be ready to explain to the ABPN how that feedback was used to foster improved care. In my opinion, if the requirement is that trivial, why do it? It is not needed to prove certifiability. The ABPN responds that it is trying to meet the requirements of its parent organization, the American Board of Medical Specialties, which demands patient feedback for certification by every medical specialty. There are a number of Action Papers coming up for the May annual meeting demanding that the APA give credence to the referendum despite its technical failure. In the meantime, efforts are being made to confront the American Board of Medical Specialties through the American Medical Association.

#### **Bishop Tutu**

One of the most contentious issues which is still churning up the APA has been the selection of Bishop Desmond Tutu as the featured speaker at the Convocation of Fellows in Hawaii. Bishop Tutu is a Nobel Prize winner for his work challenging apartheid in South Africa. Some of the Jewish members of the APA have been outraged over the selection, feeling that Bishop Tutu's opinions regarding the Palestinians are anti-Semitic. Bishop Tutu was selected by President Carol Bernstein who herself is Jewish. Much of the fight that followed the selection has been waged by APA Jewish members on both sides of the debate. Some members have indicated that they will boycott the Annual Meeting because of the selection. Non-Jewish APA members by and large have been keeping their heads down, trying to avoid getting involved in any public

The University's official announcement of this transition details the breadth of his contributions to the University and to the larger field of psychiatry, particularly in the areas of HIV and LGBT mental

"Dr. Jeffrey S. Akman, chair of the George Washington Department of Psychiatry and Behavioral Sciences, will serve as interim dean of the School of Medicine and Health Sciences and Vice Provost for health affairs. Dr. Akman brings to the position more than 33 years of service to the school, including 25 years as a full-time faculty member and numerous leadership roles. A graduate of the M.D. program, Dr. Akman also completed his residency at GW.

Dr. Akman currently leads a department of more than 300 faculty members, oversees the department's clinical practice of general adult psychiatry and serves as Chief of the Psychiatry Service of The George Washington University Hospital. In addition, Dr. Akman has directed and taught all of the major psychiatry and behavioral sciences courses for GW medical and health sciences students; taught medical humanities courses and has counseled, advised and mentored countless GW medical students and residents. A recipient of the school's Distinguished Teacher Award, he was inducted into its Society of Distinguished Teachers in 1998. He is a recipient of the GW Chapter of the AAMC Physician Humanism Award and was inducted into the Alpha Omega Alpha Medical Honor Society."

And this from the University's biographical sketch:

"One of a handful of psychiatrists who defined and developed the field of HIV/AIDS psychiatry in the mid-1980's, Dr. Akman is nationally recognized for his expertise in HIV/AIDS neuropsychiatry and in the psychiatric care of gay, lesbian, bisexual and transgender individuals. He continues to have a clinical practice of general adult psychiatry with a particular interest in HIV/AIDS neuropsychiatry and GLBT mental health issues.

Dr. Akman has provided extensive volunteer service to the community, including providing pro bono service to the clients and staff of several nonprofit community organizations, and serving on the boards of directors of Food & Friends, the Whitman-Walker Clinic (President, 1992-3), the National Lesbian & Gay Health Association (President, 1996-98), the Washington Psychiatric Society (President, 2003-04), the Medical Society of the District of Columbia, and the Samaritans of DC.

Dr. Akman is a Distinguished Fellow of the American Psychiatric Association and a member of the American College of Psychiatrists. He was named one of 'America's Top Psychiatrists' and one of the 'Best Doctors in America'".

Since this announcement, Washington, D.C., Mayor Vincent Gray has appointed

Jeff to serve on the newly created Mayor's Commission on HIV/AIDS. Again we congratulate Jeff on his achievements and deserved recognition. We wish him well with the challenges ahead.

# Gene Robinson winner of the 2011 AGLP John Fryer, MD Award



GLP will honor The Right Rev. V. Gene Robinson with their 2011 John Fryer, MD Award in Honolulu in May of 2011. The award will be presented before Bishop Robinson's lecture on Saturday, May 14, 2011, 12:00pm, at the Hawaii Convention Center, Room 311.

Rev. Robinson was elected Bishop of the Episcopal Diocese of New Hampshire on June 7, 2003, after having served as Assistant to the Bishop for nearly 18 years. He was consecrated a Bishop on November 2, 2003, and was invested as the Ninth Bishop of New Hampshire on March 7, 2004. Bishop Robinson, who married his partner in 2008, is the first openly gay, non-celibate priest to be ordained a Bishop in a major Christian denomination. In reaction to his elec-

tion and its ratification, some theologically conservative parishes have aligned themselves with bishops outside the Episcopal Church in the United States. Bishop Robinson had to wear a bullet-proof vest at his consecration, and has been under intense public scrutiny as a lightning rod for the Church's and public's conflicting views on homosexuality.


A 1969 graduate of the University of the South, Sewanee, Tennessee, Bishop Robinson has a B.A. in American Studies/History. In 1973, he completed the divinity degree at the General Theological Seminary in New York, was ordained deacon, and then priest, serving as Curate at Christ Church, Ridgewood, New Jersey. Upon moving to New Hampshire in 1975, he co-owned and directed an ACA accredited horseback riding summer camp for girls. As Founding Director of Sign of the Dove Retreat Center in New Hampshire, he led retreat programs for all kinds of parish groups.

Co-author of three AIDS education curricula for youth and adults, Bishop Robinson has done AIDS work in the United States and in Africa. He has been an advocate for anti-racism training in his diocese and in the wider Church. He helped build the Diocese of New Hampshire's close working partnership with the New Hampshire Community Loan Fund, and is a past member of the Board of the New Hampshire Endowment for Health, which works for access to health care for the uninsured.

Bishop Robinson has been an advocate of full civil rights for lesbian, gay, bisexual and transgender (LGBT) people. Working at the state, national and international levels, he has spoken and lobbied for equal protection under the law and full civil marriage rights. In international visits, he has met with lesbian and gay Christian groups, some of whom must meet in secret, thus providing them with support and exposing as fiction the idea that gay people or gay Christians do not exist in those countries.

He has been honored by many LGBT organizations for this work, including The Human Rights Campaign, the National Gay & Lesbian Task Force and the Gay and Lesbian Alliance Against Defamation. Bishop Robinson was invited by President Barack Obama to give the invocation at the opening inaugural ceremonies at the Lincoln Memorial on January 18, 2009.

The John E Fryer, MD Award honors an individual whose work has contributed to the mental health of sexual minorities. The award was endowed through a generous grant from the Gill Foundation, a bequest from the estate of psychia trist Frank Rundle, and contributions from many AGLP members. Other past awardees include Barbara Gittings and Franklin Kameny; Past APA President Laurence Hartmann; Psychiatrist and Researcher Richard Pillard; San Francisco Mayor Gavin Newsome; and the most recent, LGBT activist Evan Wolfson.

The Member Referendum raising concern about the new standards of the ABPN's Maintenance of Certification failed because less than 40% of members voted. Of the 25% that did vote, 80% supported the referendum. The referendum position was that the patient feedback requirements for the purpose of reporting to the Board was unacceptable, as it creates ethical conflicts, and has the potential to damage treatment. Additionally, the requirements other than a cognitive knowledge examination once in 10 years, regular participation in continuing medical education and maintenance of licensure, pose an undue and unnecessary burden on psychiatrists.

way. The Assembly turned down an emergency Action Paper calling for the APA to rescind its invitation to Bishop Tutu. Parenthetically, with regard to LGBT matters, Bishop Tutu admonishes his African brethren that homophobia is akin to racism — a stand which is particularly important in a continent in which one country (Uganda) is proposing death sentences for gays and another (Kenya) is contemplating a plan to start arresting gays.

#### Uganda

Speaking of Uganda, The Hon. David Bahati, a member of the Ugandan Parliament, has introduced an Anti-Homosexuality Bill in the Ugandan Parliament calling for:

- Seven years of imprisonment for anyone who attempts to engage in homosexual contact
- Life imprisonment for anyone who engages in sexual penetration of a member of the same gender
- 3. Death for "aggravated homosexuality" which includes repeated offenses of homosexuality or engaging in a homosexual act while HIV-positive
- 4. Imprisonment of up to three years for failing to report violations of the statute within 24 hours of awareness of the offense

The bill has been supported by the Ugandan National Association of Social Workers using concepts drawn from religious ideology (Uganda is 85% Christian) and from "scientific" studies of 50 years ago that have long since been discredited by the scientific community. The bill has gone back and forth as international pressure has mounted. It is unclear if the bill will come up in this session of the Ugandan Parliament or whether it will remain tabled. In the meantime, I have submitted an Action Paper asking the APA, through the Council on Minority Mental Health and Health Disparities, to reaffirm the APA position that there is no credible scientific evidence that: same sex attraction is pathological; that same sex attraction is chosen; that there is any need for "cure" of same sex attraction; or that same sex attraction entails a threat to heterosexual families or to children. The AP further asks the APA to reaffirm its condemnation of societal scapegoating, criminalization, and stigmatization of gay, lesbian, and bisexual peoples.

#### Closina

One of the lessons that I have learned from the issues described above is that so much of what happens in the APA is managed by a relatively small group of insiders. A number of us in the Assembly are committed to reaching out to the membership to make certain that members' views and issues receive ample representation. I therefore want to emphasize that I welcome and seek views and issues coming directly from AGLP members. I would like nothing better than to bring Action Papers to the Assembly (or to other arms of APA governance) that were suggested and developed by individual members of AGLP.

Finally, I want to extend my heartfelt thanks to Dr. George Harrison, who has edited the AGLP Newsletter over these many years and tolerated the gastric distress that I have given him with some of my more controversial postings. I wish him the best of all good wishes as he completes his tour of duty with this issue and look forward to working with Dr. Eric Yarbrough who is stepping into to fill George's very large shoes.


