

he Philadelphia Local Arrangements Committee welcomes you to this year's APA Annual Meeting in the City of Brotherly (and Sisterly) Love on May 18-23, 2002.

Philadelphia, over the last decade, has reinvented itself into a world-class convention town culminating in its hosting of the Republican National Convention last year. Finding hotels and taxis are no longer a problem and the city is in the midst of its second restaurant renaissance (The first being in the 1970's). In addition to the well-known daytime cultural and historic sites, the city offers a more active nightlife.

The AGLP host hotel, The Doubletree, is located on South Broad Street (renamed "The Avenue of the Arts), the home of many of the city's performing arts venues. I hope over time to understand what this has been about and how I can be part of a solution.

I hope that this edition of the newsletter can be a tribute to those who have died and suffered as a result of the September 11th tragedy. I hope we can all take a moment of silence as each of us reads this column to remember those folks.

work at a community mental health center in the Hudson Valley, about two hours north of NYC. When the second plane hit the World Trade Center on September 11, I was in a large meeting about HIPAA compliance and treatment plans. As the seriousness of the events became known, the meeting was disbanded. Many staff had family and close friends working in NYC, and were trying frantically to phone them. Some staff left work early because they live near reservoirs serving NYC, which were being closed off for security reasons. I went around the building enlisting people to work overtime taking any crisis phone calls that might come in that night.

Meanwhile, my partner was scrubbed in surgery while her hospital was being systematically emptied and searched due to a bomb scare. I remember stopping at the co-op farm where I get my vegetable share every Tuesday after work, and seeing other members availing themselves of the "pick-your-own" raspberries. How can they pick raspberries at a time like this? I wondered. I went home, hugged my partner and daughter, and saw the horrible footage for the first time, then over and over. We live near an Air National Guard base, and military planes were flying overhead most of the night.

AGLP members were affected in many ways by the attacks. We have members in NYC who have been intimately involved in the psychiatric response to the crisis. At least one member was stranded in Denver, having gone there to take the Psychiatry Oral Boards, which were cancelled due to the

attacks. Doubtless, some of us knew people who died in one of the Towers, the Pentagon, or the hijacked planes. Most of us are dealing with a spectrum of patient responses to the events, from those who have suffered family losses or direct exposure to the attacks, to those whose pre-existing PTSD symptoms, substance use problems, or paranoia have been triggered.

We have a gay hero out of the tragedy: Mark Bingham, a passenger on the plane that eventually crashed into a field in Pennsylvania, is thought to be one of the people who jumped the hijackers, thwarting their plan to crash into the assumed target of the White House. We also have the senseless comments of Jerry Falwell and Pat Robertson in the wake of the tragedy, intimating that the attacks were God's wrath against the US, for allowing gay people to have civil rights.

Still, more than as LGBT people or as psychiatrists, this tragedy has touched us all on a human level. Late in the morning of September 11, I saw a 50-year-old patient with schizophrenia for his regularly-scheduled appointment. He told me that he had been unable to reach his daughter, who works in the WTC complex, by phone. He made another try from my office, and got through to her cell phone to find out she was safe. Usually impoverished in his thinking and speech, that day he spoke at length of a daughter I had barely heard about before. For several days after the attacks, I was unable to speak to my sister, who lives downtown in NYC, as the phone circuits were continuously busy. Although my mother was able to reach her and give me reports, not hearing her voice myself was painful.

The New York Times reported that following the 9-11 tragedy, ex-spouses, estranged friends and family and old acquaintances reached out to people in NYC they hadn't spoken to in years. The

heryl made a point of reminding us of the next deadline for the submission of manuscripts for the Newsletter which was today. Nonetheless, I woke up this morning and suddenly realized that the following little comment, which I have been brooding over for a while need be written immediately. Then, as I wrote, it struck me that our Fall meeting had been held two days before the World Trade Center attack.

I am impressed again and again by the manner in which emotions distort our sense of time. It seems that the meeting, and all the events prior to the attack, happened centuries ago. In my mind, at a deep emotional level, there is a distortion in the sense of time surrounding the terrorist attack. What happened after is different in quality from what happened prior. My memories and perceptions will always, forever, be different after that day.

This is an occasion to learn about severe trauma, but, more than that, it is a situation in which we are all challenged by the exposure of our inner mental mechanisms brought about by the terrorist attack. It made me think of the fire of the Coconut Grove in Boston, when intensive, anxiety-provoking brief psychotherapy was

invented because a small group of psychiatrists counseling the survivors discovered that under conditions of high anxiety one has access not otherwise possible to deep layers of the mind.

I will not detail my experience of the attack, except to mention the unforgettable angst I felt while witnessing live on TV the fall of the first tower. With my lover and a patient whose session we had interrupted to run to the TV, I waited for the cloud of dust to dissipate, barely daring to suspect that the structure might not still be erect despite the explosion. To our horror we saw the blue sky come seeping through the smoke. I remember the people I saw jumping eighty floors from the north tower in front of my eyes, while I remained paralyzed in front of the small screen trying to make real what seemed a science fiction scenario.

Now, under siege, we feel the constant presence of the police and the military at least here in New York. The structure that this situation provides is paradoxically helpful, at least for the moment, because it reassures us in the face of having lost the basic securities of our peaceful existence within United States. For the first time in 140 years we have war in our territory. We had all forgotten what it feels like to have no certainty, to be an open country, the target of attacks and acts of war.

It seems, therefore, that our efforts at this point must be to keep everything running as normally as possible, our help to people ongoing, our inner stability intact, if not for ourselves, at least for the sake of our patients. I mean not only for the traumatized, new people who will seek help, but for our ordinary depressed, borderline, schizophrenic, narcissistic patients, whose capacity to cope may need to be boosted under the present circumstances. My patients have invariably displayed more of their usual problems. That is it.

The Fall meeting of AGLP in Washington, held on September 8, was very fruitful and pleasant. Thinking of it in hindsight, I cannot imagine any longer that kind of serenity, the sense of positive, constructive effort we

- · 508 Members, excluding Newsletter Only
- · 6% Attrition anticipated at the end of this year
- Current membership is 508 (lowest in many years). Suggestion was made that every committee should focus on membership (not just the membership committee). Discussion was held about different membership categories. Proposal was made to consider changing requirement that non APA members have to join as Associate rather than full members. Suggestions were discussed for raising membership including graduated fees for early career psychiatrists, increasing visibility of the organization within district branches, and recruiting of residents and medical students through holding events locally. Council voted to approve membership rate of \$95 for the first three years out of training and to add all members of the AGLP council to the membership committee.
- · National office is being audited as required by law in Pennsylvania. Final report is not yet finished. To date, Roy has spent 32 hrs preparing material for auditor
- -Cash flow: Generally we can expect to collect 49% of the total membership revenue for FY2002 in the months between September and December. Using this figure, we should see a total receipt of \$75,500 in membership fees received in FY2001 by year-end. Adding this to anticipated receipts for Student Travel and current receipts for grants, Roy expects the total receipts for the year to be \$104,955.00. Roy calculates disbursements based on dedicated contract amounts for the remainder of the year and expected monthly expenses. Using these methods, he expects a total disbursement of \$100,790.00 which will result in a cash surplus of \$4,165 for FY2001
- · No major expenses this year, expenses should run under budgeted amount
- Current bank has been bought by another; Roy will work with new bank and will therefore now have online access.
- · Upgrading website:

Phase 2 would introduce the interactive elements of the site, i.e.:

- o Password protected areas,
- o AGLP Newsletter Online,
- o Membership Directory,
- o Online Membership Renewal with credit card payment option

Hosting:

We currently use VERIO (a division of America Online (AOL)) for hosting. To provide the level of service required for full implementation of the AGLP Site (Phase 2), VERIO suggests a "Silver" level of service which includes:

60 MB of Ram Space

4 GB of Data Transfer space

20 email accounts

Built-in CGI Scripting

Password protected Membership-Only areas (for Directories, Newsletter Online)

Secure Manual Credit Card Processing

The monthly cost for this level of service is \$49.95. A one-time setup fee of \$50 is required (which applies to all levels of service). \$68 every two years for URL registration (required regardless of level of service chosen). Some additional scripting software would need to be purchased. Council approved this upgrade after discussion.

Where do we go from here? Vice president's column Dan Karasic, MD

aturday, October 13, 2001. I'm writing this column miserably sick with a chest cold. Oh well. As least it's not anthrax. Well, that would be extremely unlikely. That is, I don't think I've opened any powder-filled envelopes lately.

Yes, it's a crazy new world. Our leaders say to lead our lives exactly as we would before. Except be hypervigilent of our surroundings at all times because the suicide attackers could be anywhere and strike anytime.

It's been a trying month. as we tried to maintain ourselves emotionally so we could be of benefit to our patients. I have noticed that many of my patients seem to be taking the events of the last month in stride, but for others, the terrorist attacks have brought back past grief and trauma. As people living with HIV, my patients already have been living with the threat of sudden death, scary pathogens, and the loss of loved ones.

The AGLP Fall Meeting in Washington D.C. seems long distant, but it was only five weeks ago, three days before the terrorist attacks. We discussed the AGLP Saturday conference in Philadelphia, in May 2002. We are pleased to have Debbie Carter, MD coordinating the Saturday Symposium, on issues of race, ethnicity and culture in our LGBT patients. These issues remain as critical as ever in our clinical work.

At the Fall meeting, we discussed having an afternoon mini-retreat, which would follow the Saturday morning symposium. We'd like to involve the members of AGLP in shaping our future priorities as an organization and in LBGT mental health advocacy. In August, I went to a three-day meeting of an international group of LGB psychologists to plan an agenda on sexual orientation and mental health. I found it inspiring to think of how we can make positive impacts as LGBT mental health professionals, beyond planning for the next symposium or reception. Thirty years ago, a gay psychiatrist felt the need to wear a mask to protect his identity, in order to speak at APA. Now, the APA follows our lead on issues such as reparative therapy and same sex unions. Where do we go from here? Has our very success lessened the need for an AGLP? How do we stay relevant in the coming years? Let's start this dialogue.

I'd like to hear your ideas about the Saturday symposium, the possible mini-retreat, and programming for the AGLP Hospitality Suite. If you 're interested in speaking, leading a meeting, helping to plan, or just want to give input, please email me at karasic@itsa.ucsf.edu.

put into action by participating in running an organization like AGLP. As the Psychoanalytic Committee chair I reported about the psychoanalytically relevant events that occurred during the Spring meeting, and I asked and obtained spots in the schedule for the three main events that the Committee will organize. They will be the Committee administrative meeting, for which I hope to see a higher participation of the membership; the workshop on shame, very successful in the past years, which will hopefully continue to be so in the future; and a new event I am trying to organize for the next Spring Meeting.

For this new event, a gay candidate in training at a psychoanalytic institute sponsored by the American Psychoanalytic Association will present psychoanalytic material from a supervised training case of a heterosexually oriented, married man who cross dresses. I will ask two or three people who can contribute relevant and stimulating comments to form a discussion panel and report their thoughts about the case, in panel discussion format in the Hospitality Suite. I think this event will be extremely exciting because it places itself at the interface between gender and sexual orientation, as well as between the issue of psychopathology versus acceptance of human behaviors from the perspective of the personal subjective experience. It should also demonstrate the nature of traditional and of less traditional approaches to treatment in different cases and varying circumstances.

I will brief the membership more about this event, with a more precise schedule and with specific names, in the next Newsletter column, when the Spring Meeting agenda will be more finalized.

Meanwhile, my heart and soul bond with each and every one of you, as we cope together with the terrible challenge that the undermining of our ordinary tenets by this 21st century style war has brought upon us.
